(5) ALL SUPERVISORS IN THE MARYLAND TRANSIT ADMINISTRATION POLICE WHO ARE EMPLOYEES IN A CAREER SERVICE POSITION THAT:

(I) <u>SUPERVISES CAREER SERVICE POSITIONS OF A LOWER</u>

GRADE;

(II) IS SUPERVISED BY AN EXECUTIVE SERVICE POSITION;

AND

(III) HAS NO AUTHORITY TO TAKE PERSONNEL ACTIONS.

<u>3–301.</u>

(a) Employees subject to this title have the right to:

(1) take part or refrain from taking part in forming, joining, supporting, or participating in any employee organization or its lawful activities;

(2) <u>be fairly represented by their exclusive representative, if any, in</u> <u>collective bargaining; and</u>

(3) except as provided in §§ 3–303 and 3–305 of this subtitle, engage in other concerted activities for the purpose of collective bargaining or other mutual aid or protection.

(b) An employee who is a member of a bargaining unit with an exclusive representative may, without the intervention of an employee organization, discuss any matter with the employer.

(C) THE RIGHTS AFFORDED TO SUPERVISORS AND SERGEANTS IN THE MARYLAND TRANSIT ADMINISTRATION POLICE UNDER THIS TITLE SHALL BE AFFORDED IN A MANNER THAT COMPLIES AND IS CONSISTENT WITH 49 U.S.C. § 5333.

(G) (1) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, ALL SUPERVISORS AND SERGEANTS IN THE MARYLAND TRANSIT ADMINISTRATION POLICE SHALL HAVE A SEPARATE BARGAINING UNIT.

(2) <u>THE MARYLAND TRANSIT ADMINISTRATION SHALL BARGAIN</u> <u>WITH THE EXCLUSIVE REPRESENTATIVE, IF ANY, OF THE BARGAINING UNIT</u> <u>ESTABLISHED UNDER PARAGRAPH (1) OF THIS SUBSECTION.</u>".
