# AMENDMENTS TO SENATE BILL 890, AS AMENDED (First Reading File Bill)

## AMENDMENT NO. 1

On page 1 of the Finance Committee Amendments (SB0890/543627/1), in line 1 of Amendment No. 1, strike "<u>a requirement</u>" and substitute "<u>requirements</u>".

On page 1 of the bill, in line 7, after "State" insert ", the standard of care for abortions, and information and support provided to the woman on whom the abortion is performed,".

# AMENDMENT NO. 2

On page 8 of the bill, in line 15, before "An" insert "(A)"; and after line 15, insert:

- "(B) (1) ON OR BEFORE JUNE 30, 2023, THE DEPARTMENT, IN CONSULTATION WITH THE APPROPRIATE HEALTH OCCUPATIONS BOARDS, SHALL DEVELOP A STANDARD OF CARE FOR THE PERFORMANCE OF ABORTIONS IN THE STATE CONSISTENT WITH THE PURPOSE OF THE STANDARD OF CARE STATED IN PARAGRAPH (2) OF THIS SUBSECTION.
- (2) THE PURPOSE OF THE STANDARD OF CARE ESTABLISHED IN PARAGRAPH (1) OF THIS SUBSECTION IS TO ENSURE THAT ABORTIONS PERFORMED IN THE STATE MEET THE HIGHEST STANDARD OF CARE POSSIBLE.
- (3) A QUALIFIED PROVIDER SHALL PERFORM AN ABORTION IN THE STATE IN A MANNER CONSISTENT WITH THE STANDARD OF CARE ESTABLISHED UNDER PARAGRAPH (1) OF THIS SUBSECTION.

- (C) (1) BEFORE AND AFTER A QUALIFIED PROVIDER PERFORMS AN ABORTION ON A WOMAN, THE QUALIFIED PROVIDER SHALL PROVIDE TO THE WOMAN:
- (I) <u>INFORMATION ABOUT THE SPECIFIC ABORTION</u>
  PROCEDURE AND ANY SIDE EFFECTS THE WOMAN MAY EXPERIENCE;
- (II) ANY INFORMATION AND SUPPORT THE QUALIFIED PROVIDER DETERMINES IS NEEDED BASED ON THE WOMAN'S HEALTH AND THE TYPE OF ABORTION PROCEDURE;
- (III) INSTRUCTIONS FOR FOLLOW-UP CARE AFTER THE ABORTION IS PERFORMED; AND
- (IV) CONTACT INFORMATION FOR THE QUALIFIED PROVIDER
  OR ANOTHER HEALTH CARE PROVIDER IF THE WOMAN HAS QUESTIONS OR NEEDS
  CARE OR SUPPORT AFTER THE ABORTION PROCEDURE.
- (2) THE INFORMATION PROVIDED UNDER PARAGRAPH (1) OF THIS SUBSECTION SHALL BE PROVIDED:
  - (I) IN THE WOMAN'S SPOKEN LANGUAGE; AND
  - (II) IN A CULTURALLY SENSITIVE MANNER.
- (D) AT LEAST ONCE AFTER A QUALIFIED PROVIDER PERFORMS AN ABORTION ON A WOMAN, THE QUALIFIED PROVIDER SHALL ATTEMPT TO CONTACT THE WOMAN TO:

- (1) REQUEST THAT THE WOMAN MAKE AN APPOINTMENT WITH
  THE QUALIFIED PROVIDER OR ANOTHER APPROPRIATE HEALTH CARE PROVIDER
  FOR FOLLOW-UP CARE AFTER THE ABORTION PROCEDURE; AND
- (2) INQUIRE ABOUT ANY HEALTH CONCERNS THE WOMAN HAS AFTER THE ABORTION PROCEDURE.".
