AMENDMENT NO. 1

On page 1, strike beginning with "establishing" in line 5 down through "Equity;" in line 6; in line 12, after the semicolon insert "requiring the Department, in collaboration with the Administration, to conduct certain analyses and consult with certain communities before announcing any reduction or cancellation of a capital expansion project in the construction program of the Consolidated Transportation Program; requiring the Administration to compile a report on the impacts of a proposed reduction or cancellation of a capital expansion project in the construction program of the Consolidated Transportation Program;"; and in line 26, strike "and 7–715" and substitute "through 7–716".

AMENDMENT NO. 2

On page 3, in line 12, strike "2023" and substitute "2024"; strike beginning with "CONSULT" in line 15 down through "TO" in line 16; and in lines 19 and 23, in each instance, strike "IMPACTS" and substitute "TO THE EXTENT DATA IS AVAILABLE, IMPACTS".

On page 5, in line 26, strike "**PERSONS**" and substitute "<u>TO THE EXTENT DATA</u> <u>IS AVAILABLE, PERSONS</u>".

On pages 8 through 11, strike in their entirety the lines beginning with line 17 on page 8 through line 2 on page 11, inclusive.

On page 11, in line 3, strike "(6) ADVISE THE" and substitute "<u>THE</u>"; in the same line, strike "ON:" and substitute "<u>SHALL DEVELOP</u>"; in line 4, strike "(I) TRANSIT" and substitute "TRANSIT"; in line 5, strike "A CHANGE TO SERVICE OR"; in

line 6, after "CAPITAL" insert "EXPANSION"; in the same line, after "PROJECT" insert "IN THE CONSTRUCTION PROGRAM OF THE CONSOLIDATED TRANSPORTATION PROGRAM"; and in the same line, strike "; AND" and substitute a period.

On pages 11 and 12, strike in their entirety the lines beginning with line 7 on page 11 through line 16 on page 12, inclusive.

On page 12, in line 21, strike "OR PROPOSING"; strike beginning with ", OR" in line 24 down through "EQUITY" in line 27.

On page 13, strike beginning with "AND" in line 3 down through "EQUITY" in line 4; in line 10, strike "AND"; after line 11, insert:

"(V) ENVIRONMENTAL JUSTICE; AND";

in line 17, strike "AND"; in line 18, after "RIDERS" insert "; AND

(VI) SENIOR RIDERS";

and strike beginning with ", ACCORDING" in line 19 down through "EQUITY," in line 20.

On page 14, in line 10, strike the colon and substitute "<u>PUBLISH ON THE</u> <u>ADMINISTRATION'S WEBSITE, FOR THE ROUTES OR LINES IMPACTED BY THE SERVICE CHANGE, AN EVALUATION ON THE DEMOGRAPHICS OF:</u>

- (1) THE RIDERS OF THE ROUTES OR LINES; AND
- (2) THE SERVICE AREA.";

(II) COMPILE".

On page 15, strike beginning with "**THE**" in line 8 down through "**5.**" in line 9; in lines 11 and 13, strike "**6.**" and "**7.**", respectively, and substitute "<u>5.</u>" and "<u>6.</u>", respectively; and after line 19, insert:

"7–716.

- (A) BEFORE ANNOUNCING ANY REDUCTION OR CANCELLATION OF A CAPITAL EXPANSION PROJECT IN THE CONSTRUCTION PROGRAM OF THE CONSOLIDATED TRANSPORTATION PROGRAM THAT EXCEEDS THE THRESHOLDS DEVELOPED BY THE ADMINISTRATION, THE DEPARTMENT, IN COLLABORATION WITH THE ADMINISTRATION, SHALL:
- (1) CONDUCT A TRANSIT EQUITY ANALYSIS IN ACCORDANCE WITH THE TITLE VI REQUIREMENTS AND GUIDELINES FOR FEDERAL TRANSIT ADMINISTRATION RECIPIENTS AND THE GUIDELINES DEVELOPED BY THE ADMINISTRATION TO DETERMINE WHETHER THE REDUCTION OR CANCELLATION WILL CREATE A DISPARATE IMPACT OR A DISPROPORTIONATE BURDEN;
- (2) PERFORM A COST-BENEFIT ANALYSIS, INCLUDING AN ANALYSIS OF IMPACTS ON:

 - (I) RACIAL MINORITY COMMUNITIES;
 - (II) LOW-INCOME COMMUNITIES;
 - (III) DISABLED RIDERS;
 - (IV) RIDERS WITH LIMITED ENGLISH PROFICIENCY;
 - (V) TRANSIT-RELIANT RIDERS; AND
 - (VI) SENIOR RIDERS.
