in the same line, strike "10%"; in the same line, after "INCREASE" insert "THAT IS COMMENSURATE WITH CURRENT LABOR MARKET TRENDS"; in line 12, after "COMPLETES" insert "AND RECEIVES A CERTIFICATION FOR"; in line 14, after "(F)" insert "(1)"; in line 16, after "THAT" insert "PROVIDES EDUCATIONAL AND JOB TRAINING PROGRAMS AND"; in the same line, after "MONEY" insert "FOR AN EMPLOYEE WHO IS A MEMBER OF A BARGAINING UNIT"; in the same line, after "AWARDED" insert "TO THE EMPLOYER"; and after line 17, insert:

"(2) THE TRAINING AND UPGRADING FUND SHALL REPORT TO THE DIVISION, IN THE MANNER SPECIFIED BY THE DIVISION, WHEN GRANT MONEY IS EXPENDED BY THE TRAINING AND UPGRADING FUND.".
