AMENDMENTS TO SENATE BILL 62
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “**Aids for the Cessation of Tobacco Product Use**” and substitute “**Nicotine Replacement Therapy Medication**”; in line 6, strike “as aids for the cessation of the use of tobacco products” and substitute “for the purpose of aiding in tobacco cessation or smoking cessation”; strike beginning with “aids” in line 7 down through “products” in line 8 and substitute “nicotine replacement therapy medications”; after line 13, insert:

“BY adding to
Article – Health Occupations
Section 12–101(o–2) and 12–514
Annotated Code of Maryland
(2021 Replacement Volume)”;

and strike in their entirety lines 19 through 21, inclusive.

AMENDMENT NO. 2

On page 2, strike in their entirety lines 1 and 2; after line 12, insert:

“(O–2) “NICOTINE REPLACEMENT THERAPY MEDICATION” MEANS A DRUG OR PRODUCT, REGARDLESS OF WHETHER IT IS AVAILABLE OVER THE COUNTER, THAT:

(1) DELIVERS NICOTINE TO AN INDIVIDUAL; AND

(2) IS APPROVED BY THE FEDERAL FOOD AND DRUG ADMINISTRATION FOR THE SOLE PURPOSE OF AIDING IN TOBACCO CESSATION OR SMOKING CESSATION.”.

On page 3, strike beginning with “APPROVED” in line 10 down through “PRODUCTS” in line 12; strike beginning with “APPROVED” in line 18 down through “PRODUCTS” in line 20; strike beginning with “AID” in line 26 down through “PATIENT” in line 27 and substitute “NICOTINE REPLACEMENT THERAPY MEDICATION”; and strike beginning with “AN” in line 31 down through “PRODUCTS” in line 32 and substitute “NICOTINE REPLACEMENT THERAPY MEDICATION”.

On page 4, strike beginning with “AIDS” in line 4 down through “PRODUCTS” in line 5 and substitute “NICOTINE REPLACEMENT THERAPY MEDICATION”; strike beginning with “AN” in line 8 down through “PRODUCTS” in line 9 and substitute “NICOTINE REPLACEMENT THERAPY MEDICATION”; in line 13, after “THE” insert “NICOTINE REPLACEMENT THERAPY”; and in line 18, strike “AID FOR THE CESSATION OF THE USE OF TOBACCO PRODUCTS” and substitute “NICOTINE REPLACEMENT THERAPY MEDICATION”.
