AMENDMENTS TO HOUSE BILL 1343, AS AMENDED
(First Reading File Bill)

AMENDMENT NO. 1

On page 1 of the bill, in line 2, before “Major” insert “Exclusive Representatives and”; in line 3, after “requiring” insert “an exclusive representative or”; in lines 4 and 7, in each instance, after “the” insert “exclusive representative or”; in line 8, after “to” insert “an exclusive representative or”; and in line 11, after “by” insert “exclusive representatives and”.

AMENDMENT NO. 2

On page 2 of the bill, in line 6, after “CONTRACTOR” insert “OR AN EXCLUSIVE REPRESENTATIVE”; in line 8, after “CONTRACTOR” insert “EXCLUSIVE REPRESENTATIVE”; after line 9, insert:

“(E) “EXCLUSIVE REPRESENTATIVE” MEANS AN ORGANIZATION THAT REPRESENTS PUBLIC OR PRIVATE SECTOR EMPLOYEES IN COLLECTIVE BARGAINING.”;

in line 12, strike “OR”; and in line 14, after “AGREEMENT” insert “; OR”

(III) AN EXCLUSIVE REPRESENTATIVE OF EMPLOYEES IN THE PRIVATE SECTOR WHO WILL WORK OR ARE WORKING ON A MAJOR STATE PROJECT OR OF EMPLOYEES IN THE PUBLIC SECTOR WHO WORK FOR A UNIT OF STATE OR LOCAL GOVERNMENT”.

On page 3 of the Environment and Transportation Committee Amendments (HB1343/433126/1), in line 3 of Amendment No. 2, strike “(D)” and substitute “(E)”; in the same line, strike “(E)” and substitute “(F)”; in the same line, strike “(F)” and

substitute “**(G)**”; in line 4, strike “**(G)**” and substitute “**(H)**”; in the same line, strike “**(H)**” and substitute “**(I)**”; and in the same line, strike “**(I)**” and substitute “**(J)**”.

On page 3 of the bill, in line 4, strike “**A**” and substitute “**AN EXCLUSIVE REPRESENTATIVE OR A**”; in line 6, after “**THE**” insert “**EXCLUSIVE REPRESENTATIVE OR**”; in line 23, after the second “**THE**” insert “**EXCLUSIVE REPRESENTATIVE OR**”; in lines 25 and 29, in each instance, after “**THE**” insert “**EXCLUSIVE REPRESENTATIVE OR**”; and in line 28, after “**OF**” insert “**AN EXCLUSIVE REPRESENTATIVE OR**”.

On page 4 of the bill, in lines 1, 6, 7, 10, 11, 14, and 18, in each instance, after “**OF**” insert “**AN EXCLUSIVE REPRESENTATIVE OR**”; in lines 3 and 15, in each instance, after the second “**THE**” insert “**EXCLUSIVE REPRESENTATIVE OR**”; in lines 8, 16, and 21, in each instance, after “**THE**” insert “**EXCLUSIVE REPRESENTATIVE OR**”; and in line 12, after the third “**THE**” insert “**EXCLUSIVE REPRESENTATIVE OR**”.

On page 5 of the bill, in lines 1 and 5, in each instance, strike “**A**” and substitute “**AN EXCLUSIVE REPRESENTATIVE OR A**”; in lines 3 and 4, in each instance, after “**THE**” insert “**EXCLUSIVE REPRESENTATIVE OR**”; and in line 23, after “**OF**” insert “**AN EXCLUSIVE REPRESENTATIVE OR**”.
