AMENDMENTS TO SENATE BILL 3
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “**Safety**” and substitute “**Children and Community Relations**”; in line 12, strike “and, under certain circumstances, a certain community relations plan”; and in lines 13 and 14, strike “and, if applicable, certain community relations plans”.

AMENDMENT NO. 2

On page 2, in line 12, after “**PLAN**” insert “**NOT LESS THAN**”; and after line 12, insert:

“(D) A STATE RESIDENTIAL CENTER MAY SATISFY THE REQUIREMENT UNDER SUBSECTION (C) OF THIS SECTION BY IMPLEMENTING A SAFETY OR EMERGENCY PLAN ESTABLISHED FOR THE CENTER FOR ANOTHER PURPOSE.”

On page 3, in line 3, strike “**ESTABLISH**” and substitute “:

1. ESTABLISH”;

in line 5, after “**HOME**” insert “**;** **OR**

2. IMPLEMENT A SAFETY OR EMERGENCY PLAN ESTABLISHED FOR THE PRIVATE GROUP HOME FOR ANOTHER PURPOSE”;

in line 10, after “**(I)**” insert “**1.**”; in line 11, strike “**AND**” and substitute “**OR**

2. IMPLEMENT A SAFETY OR EMERGENCY PLAN ESTABLISHED FOR THE PROGRAM FOR ANOTHER PURPOSE;;

in line 12, after “PLAN” insert “NOT LESS THAN”; and in the same line, after “YEARS,” insert “AND

(III) INCLUDE IN THE SAFETY PLAN A STATEMENT CERTIFYING COMPLIANCE WITH:

1. THE NATIONAL FIRE PROTECTION ASSOCIATION 101: LIFE SAFETY CODE; AND

2. THE NATIONAL FIRE PROTECTION ASSOCIATION 99: HEALTH CARE FACILITIES CODE;”.

On page 5, in line 2, strike “AND, IF APPLICABLE, A COMMUNITY RELATIONS PLAN”; in lines 4 and 5, strike “AND, IF APPLICABLE, ITS COMMUNITY RELATIONS PLAN” and substitute “NOT LESS THAN”; after line 5, insert:

“(E) A FACILITY MAY SATISFY THE REQUIREMENT UNDER SUBSECTION (C) OF THIS SECTION BY IMPLEMENTING A SAFETY OR EMERGENCY PLAN ESTABLISHED FOR THE FACILITY FOR ANOTHER PURPOSE.”;

in line 16, after “(I)” insert “1.”; in line 17, after “FACILITY;” insert “OR

2. IMPLEMENT A SAFETY OR EMERGENCY PLAN ESTABLISHED FOR THE FACILITY FOR ANOTHER PURPOSE;”;

and in line 18, after “PLAN” insert “NOT LESS THAN”.

On page 6, in line 30, after “PLAN” insert “OR A SAFETY OR EMERGENCY PLAN ESTABLISHED FOR THE FACILITY FOR ANOTHER PURPOSE”.

On page 7, in line 1, after “REVISED” insert “NOT LESS THAN”.
