### AMENDMENT NO. 1

On page 1, strike beginning with "<u>providing</u>" in line 8 down through "<u>Program</u>;" in line 9.

On page 2, in line 5, strike "7–1102 and 7–1103" and substitute "<u>7–1102, 7–1103,</u> <u>and 7–1106</u>".

### AMENDMENT NO. 2

On page 2, strike beginning with the first "the" in line 29 down through "body" in line 30 and substitute "<u>A PERSONAL RESTRICTION THAT IMMOBILIZES A STUDENT</u> <u>OR REDUCES THE ABILITY OF A STUDENT TO MOVE THEIR TORSO, ARMS, LEGS,</u> <u>OR HEAD FREELY THAT OCCURS</u>".

On page 3, after line 23, insert:

# "(A) THIS SECTION DOES NOT APPLY TO THE JUVENILE SERVICES EDUCATION PROGRAM.";

in lines 24 and 27, strike "(A)" and "(B)", respectively, and substitute "<u>(B)</u>" and "<u>(C)</u>", respectively; and in line 24, strike "<u>EXCEPT AS PROVIDED IN SUBSECTION (E) OF</u> <u>THIS SECTION, A</u>" and substitute "<u>A</u>".

On page 4, in lines 3 and 10, strike "(C)" and "(D)", respectively, and substitute "(D)" and "(E)", respectively.

On page 5, in line 14, strike "(D)" and substitute "<u>(E)</u>"; and strike in their entirety lines 30 and 31.

On page 6, in line 9, after "OPPORTUNITY" insert "<u>, BUT NOT LONGER THAN 4</u> <u>BUSINESS DAYS AFTER THE STUDENT'S 10TH INCIDENT OF PHYSICAL</u> <u>RESTRAINT</u>"; in line 14, after "OPPORTUNITY" insert "<u>, BUT NOT LONGER THAN 4</u> <u>BUSINESS DAYS AFTER THE STUDENT'S 10TH INCIDENT OF PHYSICAL RESTRAINT</u> <u>OR SECLUSION</u>"; in line 22, strike "AGENCY" and substitute "<u>SCHOOL</u>"; and in line 29, after "OPPORTUNITY" insert "<u>, BUT NOT LONGER THAN 4</u> BUSINESS DAYS AFTER <u>THE STUDENT'S 10TH INCIDENT OF PHYSICAL RESTRAINT</u>".

# (A) A PUBLIC AGENCY AND THE LOCAL SCHOOL SYSTEM IN WHICH THE PUBLIC AGENCY IS LOCATED OR A NONPUBLIC SCHOOL SHALL SUBMIT A SYSTEMIC, EVIDENCE-BASED CORRECTIVE ACTION PLAN TO THE DEPARTMENT IF THE PUBLIC AGENCY OR NONPUBLIC SCHOOL:

(1) FAILS TO COMPLY WITH ANY PROVISION OF THIS SUBTITLE; OR

# (2) <u>REPORTS TO THE DEPARTMENT THAT A STUDENT HAS BEEN</u> PHYSICALLY RESTRAINED OR PLACED IN SECLUSION 10 TIMES OR MORE IN A SCHOOL YEAR UNDER § 7–1103 OF THIS SUBTITLE.

# (B) <u>THE DEPARTMENT SHALL ADOPT REGULATIONS TO IMPLEMENT THE</u> <u>PROVISIONS OF THIS SECTION.</u>";

and in line 22, strike "7–1106." and substitute "7–1107.".
