AMENDMENTS TO HOUSE BILL 226, AS AMENDED
(First Reading File Bill)

AMENDMENT NO. 1

On page 1 of the Ways and Means Committee Amendments (HB0226/363928/1), in line 2 of Amendment No. 1, strike "**Pilot Program**"; strike beginning with "the" in line 3 down through "Program." in line 5 and substitute "a program for"; in line 8, strike "participating in the Pilot Program"; in line 10, strike "certain"; and in lines 13 and 14, strike "Self-Contained Special Education Classroom Video Recording Pilot Program" and substitute "use of video recording devices in self-contained special education classrooms".

On page 1 of the bill, in lines 2 and 3, strike "**Video Recording**" and substitute "- Use of Video Recording Devices".

AMENDMENT NO. 2

On page 2 of the bill, strike in their entirety lines 12 through 14, inclusive; and in lines 15, 21, and 23, strike "**(5)**", "**(6)**", and "**(7)**", respectively, and substitute "**(4)**", "**(5)**", and "**(6)**", respectively.

On page 1 of the Ways and Means Committee Amendments, in lines 1 and 2 of Amendment No. 2, strike "**PILOT PROGRAM**"; and in lines 3 and 4, strike "**THE SELF-CONTAINED SPECIAL EDUCATION CLASSROOM VIDEO RECORDING PILOT PROGRAM**".

On pages 1 and 2 of the Ways and Means Committee Amendments, in Amendment No. 2, strike beginning with "**(I)**" in line 9 on page 1 down through "**NECESSARY.**" in line 8 on page 2.

On page 2 of the Ways and Means Committee Amendments, in line 9 of Amendment No. 2, strike “**(2)**”; and in lines 10 and 11, strike “**SELECTED IN ACCORDANCE WITH PARAGRAPH (1) OF THIS SUBSECTION**”.

On page 3 of the Ways and Means Committee Amendments, in line 1 of Amendment No. 2, strike “**PUBLIC SCHOOL PARTICIPATING IN THE PILOT PROGRAM**” and substitute “**COUNTY BOARD**”; in line 8, strike “**PARTICIPATING IN THE PILOT PROGRAM**”; and in lines 13 and 14, strike “**PARTICIPATING IN THE PILOT PROGRAM**”.

On page 3 of the bill, in lines 5 and 12, strike “**(3)**” and “**(4)**”, respectively, and substitute “**(2)**” and “**(3)**”, respectively.

On page 4 of the Ways and Means Committee Amendments, in lines 1 and 2 of Amendment No. 2, strike “**PARTICIPATING IN THE PILOT PROGRAM**”; in line 18, strike “**PARTICIPATING IN THE PILOT PROGRAM**”; and in line 22, strike “**THE PILOT PROGRAM**” and substitute “**THIS SECTION**”.

On page 5 of the Ways and Means Committee Amendments, in line 3 of Amendment No. 2, strike “**PARTICIPATING IN THE PILOT PROGRAM**”; in line 5, strike “**PARTICIPATING IN THE PILOT PROGRAM**”; in line 16, strike “**OF**” and substitute “**AMONG**”; in line 17, strike “**SCHOOLS PARTICIPATING IN THE PILOT PROGRAM WITH OTHER**”; and in lines 18 and 19, strike “**FOR BOTH PARTICIPATING PUBLIC SCHOOLS AND OTHER PUBLIC SCHOOLS**”.

On page 6 of the Ways and Means Committee Amendments, in lines 14 and 15 of Amendment No. 2, strike “**THAT PARTICIPATES IN THE PILOT PROGRAM**”; and in line 15, strike “**PARTICIPATION**” and substitute “**CARRYING OUT THIS SECTION**”.

On page 7 of the Ways and Means Committee Amendments, in line 1 of Amendment No. 2, strike "ADMINISTER THE PILOT PROGRAM" and substitute "CARRY OUT THIS SECTION".
