AMENDMENTS TO HOUSE BILL 1276

(Third Reading File Bill)

On page 3, strike beginning with “OR” in line 21 down through “MAYOR” in line 22; in lines 23 and 24, strike “BALTIMORE’S PROMISE; AND” and substitute “THE CITY COUNCIL OF BALTIMORE CITY;”; and in line 25, after “COMMISSIONERS” insert “; AND”

(4) ANY OTHER PUBLIC, QUASI-PUBLIC, OR PRIVATE ENTITY THAT CONTRIBUTES DATA TO THE BALTIMORE CITY YOUTH DATA HUB.

(L) “QUERY” MEANS TO SEARCH, FIND, AND ANALYZE DATA IN THE BALTIMORE CITY YOUTH DATA HUB”.

On page 4, in lines 1 and 6, strike “(L)” and “(M)”, respectively, and substitute “(M)” and “(N)”, respectively; strike beginning with “ANY” in line 24 down through “EXECUTIVE” in line 25 and substitute “REPRESENTATIVES FROM OTHER PROVIDERS”.

On page 5, in line 11, after “(A)” insert “(1)”; after line 13, insert:

“(2) THE PARTICIPATION OF THE MAYOR OF BALTIMORE CITY, THE CHIEF EXECUTIVE OFFICER OF THE BALTIMORE CITY PUBLIC SCHOOL SYSTEM, OR THEIR DESIGNEES IN THE EXECUTIVE COMMITTEE DOES NOT SUBJECT THE BALTIMORE CITY YOUTH DATA HUB TO THE PUBLIC INFORMATION ACT OR THE OPEN MEETINGS ACT.”;

and strike beginning with “(I)” in line 26 down through “(II)” in line 29.

On page 6, in line 6, after “(A)” insert “NOTWITHSTANDING ANY OTHER PROVISION OF LAW, ANY STATE OR LOCAL GOVERNMENTAL ENTITY OR PRIVATE OR QUASI-GOVERNMENTAL ENTITY MAY PROVIDE PERSONALLY IDENTIFIABLE INFORMATION AND DATA FOR THE BALTIMORE CITY YOUTH DATA HUB.”; in line 10, before “ON” insert “(B)”; in the same line, strike “ON REQUEST OF THE MANAGER, A” and substitute “A”; strike beginning with “RELATED” in line 11 down through “PURPOSE” in line 12 and substitute “AND OTHER DATA”; and in line 14, strike “(B)” and substitute “(C)”.
