(4) A PERSONAL IDENTIFIER, INCLUDING AN INDIVIDUAL'S SOCIAL SECURITY NUMBER, STUDENT IDENTIFICATION NUMBER, OR BIOMETRIC RECORD;

(5) AN INDIRECT IDENTIFIER, INCLUDING AN INDIVIDUAL'S DATE OF BIRTH, PLACE OF BIRTH, OR MOTHER'S MAIDEN NAME; AND

<u>(6)</u>";

in line 10, after "CITY" insert "<u>OR A UNIT WITHIN THE OFFICE OF THE MAYOR</u>"; in line 11, strike "THE CITY COUNCIL OF BALTIMORE CITY;" and substitute "<u>BALTIMORE'S PROMISE; AND</u>"; strike beginning with the semicolon in line 12 down through "HUB" in line 16; and in lines 17 and 22, strike "(M)" and "(N)", respectively, and substitute "(L)" and "(M)", respectively.

On page 4, in line 11, strike "**REPRESENTATIVES FROM OTHER PROVIDERS**" and substitute "<u>ANY OTHER INDIVIDUALS JOINTLY SELECTED BY THE MAYOR AND</u> <u>THE CHIEF EXECUTIVE</u>"; and in line 24, strike "(1)".

On page 5, strike in their entirety lines 1 through 5, inclusive; in line 13, after "(4)" insert "(I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE MANAGER MAY CONTRACT WITH A TECHNOLOGY VENDOR OR OTHER PROFESSIONAL.

in the same line, after "OR" insert "<u>OTHER</u>"; strike beginning with "NOTWITHSTANDING" in line 23 down through "A" in line 27 and substitute "<u>ON</u> <u>REQUEST OF THE MANAGER, A</u>"; in line 28, strike "AND OTHER DATA" and substitute "<u>RELATED TO THE BALTIMORE CITY YOUTH DATA HUB'S PURPOSE</u>"; and in line 29, strike "(C)" and substitute "<u>(B)</u>".
