AMENDMENTS TO SENATE BILL 516
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with “altering” in line 3 down through “Program;” in line 6; in line 9, after “Transportation” insert “, in collaboration with the Department of Housing and Community Development,”; and strike in their entirety lines 13 through 22, inclusive.

AMENDMENT NO. 2

On pages 2 through 6, strike in their entirety the lines beginning with line 29 on page 2 through line 8 on page 6, inclusive.

On page 7, in line 18, after “DEPARTMENT” insert “, IN COLLABORATION WITH THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT,”.

On page 8, in line 6, strike “2023” and substitute “2025”; strike beginning with “AND” in line 6 down through “THEREAFTER,” in line 7; strike beginning with “DURING” in line 16 down through “COVERS” in line 17 and substitute “FROM JULY 1, 2018, THROUGH JULY 1, 2025”; and in line 20, after “DEPARTMENT” insert “, IN COLLABORATION WITH THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT,”.

On page 9, in line 19, after “(B)” insert “THE DEPARTMENT, IN COLLABORATION WITH THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT, SHALL ADMINISTER THE FUND.”

On page 10, in line 12, strike “(D)” and substitute “(E)”; in the same line, strike “EACH”; in the same line, after “YEAR” insert “2024”; in line 13, strike “AN” and substitute “A GENERAL FUND”; strike beginning with “SUFFICIENT” in line 13 down through “BALANCE” in line 14; in line 14, strike “AT LEAST”; in the same line, strike “AT THE START OF THE FISCAL YEAR” and substitute “TO THE FUND”; in line 16, after “DEPARTMENT” insert “, IN COLLABORATION WITH THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT,”; and in line 29, after “DEPARTMENT” insert “, IN COLLABORATION WITH THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT,”.

On page 11, in line 2, strike “AND”; in line 4, after “WEBSITE” insert “; AND”

(III) PRIORITIZE GEOGRAPHIC EQUITY IN ITS ALLOCATIONS OF GRANTS AND LOANS”;

in line 5, after “(2)” insert “THE DEPARTMENT, IN COLLABORATION WITH THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT, MAY NOT ALLOCATE MORE THAN 50% OF THE FUNDS AVAILABLE IN A FISCAL YEAR TO A SINGLE APPLICANT.”
