AMENDMENTS TO HOUSE BILL 277

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**and Valentino-Smith**” and substitute “**Valentino-Smith, Griffith, McKay, C. Branch, Thiam, Saab, R. Jones, Attar, Atterbeary, Boteler, Charles, Ebersole, Feldmark, Hartman, Hornberger, D. Jones, Long, and Rose**”.

AMENDMENT NO. 2

On page 1, in line 19, strike “**OR FORMER**”.

On page 2, in line 10, after “**FAMILIES**” insert “**WHEN, AS A RESULT OF MILITARY SERVICE, A MILITARY-CONNECTED STUDENT TRANSFERS SCHOOLS**”; in line 12, strike “**THE**” and substitute “**SUBJECT TO SUBSECTION (D) OF THIS SECTION, THE**”; in lines 13 and 14, strike “**QUALIFIES FOR THE DESIGNATION UNDER SUBSECTION (D) OF THIS SECTION**” and substitute “**MEETS THE CRITERIA ADOPTED BY THE DEPARTMENT FOR A PURPLE STAR SCHOOL**”; in line 15, strike “**TO QUALIFY AS A PURPLE STAR SCHOOL, A PUBLIC SCHOOL SHALL**” and substitute “**AT A MINIMUM, THE DEPARTMENT’S CRITERIA FOR A PURPLE STAR SCHOOL SHALL REQUIRE A PUBLIC SCHOOL TO**”; in line 18, after “**STUDENTS**” insert “**WHO ARE NEWLY ENROLLED OR SOON TO BE**”; in line 21, after “**AND**” insert “**NEWLY ENROLLED OR SOON TO BE ENROLLED**”; in line 23, after “**TO**” insert “**NEWLY ENROLLED OR SOON TO BE ENROLLED**”; in the same line, strike “**AND**”; in line 25, strike “**RELEVANT TO**” and substitute “**FOR NEWLY ENROLLED OR SOON TO BE ENROLLED**”; and in the same line, after the semicolon insert “**AND**”

On page 3, in line 9, after the semicolon insert "AND"; in line 11, after "STUDENTS" insert "TRANSFERRING TO NEW SCHOOLS"; strike beginning with the semicolon in line 11 down through "TRIP" in line 20; in line 22, strike "THE FOLLOWING REQUIREMENTS" and substitute "THE DEPARTMENT'S CRITERIA"; and strike beginning with "UNDER" in line 22 down through "SECTION" in line 29.
