AMENDMENTS TO SENATE BILL 438
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 8, strike “counties” and substitute “affiliated services”; in line 10, after “programs;” insert “authorizing an affiliated service to apply for a program grant; requiring a program grant to be disbursed to a qualifying affiliated service;”; and in line 23, strike “and” and substitute “now, therefore,”.

On pages 1 and 2, strike in their entirety the lines beginning with line 24 on page 1 through line 1 on page 2, inclusive.

AMENDMENT NO. 2

On page 2, strike in their entirety lines 7 through 11, inclusive, and substitute:

“IN THIS SUBTITLE, “EARLY READER ORGANIZATION” MEANS A NONPROFIT ORGANIZATION:

(1) THAT IS TAX EXEMPT UNDER § 501(C)(3) OF THE INTERNAL REVENUE CODE; AND

(2) WHOSE MISSION IS TO MAIL TO CHILDREN FREE, HIGH-QUALITY BOOKS DESIGNED TO AID THE DEVELOPMENT OF READING SKILLS.”;

strike beginning with “DOLLY” in line 17 down through “LIBRARY” in line 18 and substitute “AN EARLY READER ORGANIZATION”; in line 22, strike “A NONPROFIT” and substitute “AN EARLY READER ORGANIZATION”; and in line 23, strike “(501(C)(3))”.

On page 3, in line 3, strike “**AFFILIATED WITH DOLLY PARTON’S IMAGINATION LIBRARY**” and substitute “**PERFORMED BY A NONPROFIT ORGANIZATION THAT IS TAX EXEMPT UNDER § 501(C)(3) OF THE INTERNAL REVENUE CODE OR A UNIT OF STATE, COUNTY, OR MUNICIPAL GOVERNMENT THAT FORMS AN AFFILIATED PARTNERSHIP WITH AN EARLY READER ORGANIZATION**”; in lines 8 and 9, strike “**COUNTIES THAT**” and substitute “**AFFILIATED SERVICES TO**”; in line 13, strike “**IN THE COUNTY**”; in line 15, strike “**A COUNTY**” and substitute “**AN AFFILIATED SERVICE**”; strike beginning with the colon in line 17 down through “**(II)**” in line 20; in line 22, strike “**THE COUNTY**” and substitute “**ITS AREA OF SERVICE**”; after line 22, insert:

“(3) A PROGRAM GRANT SHALL BE DISBURSED TO AN AFFILIATED SERVICE THAT QUALIFIES FOR THE PROGRAM.”;

and in line 24, strike “**\$500,000**” and substitute “**\$250,000**”.
