AMENDMENT TO SENATE BILL 319  
(First Reading File Bill)

On page 1, after line 23, insert:

**“(B) “ADDITIONS” HAS THE MEANING STATED IN THE INTERNATIONAL SWIMMING POOL AND SPA CODE.**

**“(C) “ALTERATIONS” HAS THE MEANING STATED IN THE INTERNATIONAL SWIMMING POOL AND SPA CODE.”.**

On page 2, in lines 1, 2, 8, 11, 13, and 15, strike **“(B)”**, **“(C)”**, **“(D)”**, **“(E)”**, **“(F)”**, and **“(G)”**, respectively, and substitute **“(D)”**, **“(E)”**, **“(F)”**, **“(H)”**, **“(I)”** and **“(J)”**, respectively; after line 10, insert:

**“(G) “REPAIRS” HAS THE MEANING STATED IN THE INTERNATIONAL SWIMMING POOL AND SPA CODE.”;**

and in line 24, after **“TO”** insert **“:**

**(I) ENFORCE THE STANDARDS FOR THE DESIGN AND CONSTRUCTION, INCLUDING ADDITIONS, ALTERATIONS, OR REPAIRS, OF PUBLIC SWIMMING POOLS; OR**

**(II)”.**

On page 3, in line 2, strike **“THE”** and substitute **“(I) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE”**; after line 5, insert:

“(II) THE DEPARTMENT SHALL ADOPT, AS PART OF THE STANDARDS, THE PROVISIONS OF THE INTERNATIONAL SWIMMING POOL AND SPA CODE RELATING TO THE REQUIREMENTS FOR ADDITIONS, ALTERATIONS, AND REPAIRS WITHOUT MODIFICATION.”;

in line 8, strike “(1)”; in lines 10, 13, 15, 19, 21, 22, and 23, strike “(I)”, “(II)”, “(III)”, “(IV)”, “(V)”, “(VI)”, and “(VII)”, respectively, and substitute “(1)”, “(2)”, “(3)”, “(4)”, “(5)”, “(6)”, and “(7)”, respectively; and strike in their entirety lines 25 through 28, inclusive.

On page 5, in line 4, strike “WORK”; in line 5, strike the second “WORK”; and in line 31, strike “2021” and substitute “2022”.

On page 8, strike beginning with the colon in line 6 down through “change,” in line 12 and substitute “this Act does not apply to a swimming pool or spa built and in operation before June 1, 2023, unless there is construction or renovation that results in a substantial and material structural change to the swimming pool or spa that”; and in line 13, strike “the effective date of this Act” and substitute “June 1, 2023”.
