AMENDMENT NO. 1

On page 1 of the bill, strike beginning with "repealing" in line 3 down through "county" in line 4 and substitute "altering the hiring process for a county health officer"; in line 6, after "the" insert "employment and"; and in line 10, after "3–302" insert "and 3–304(b)".

On page 1 of the Health and Government Operations Committee Amendments (HB0609/923723/1), in Amendment No. 1, strike beginning with "<u>BY</u>" in line 4 down through "<u>Supplement</u>)" in line 8.

AMENDMENT NO. 2

On page 1 of the bill, in line 17, after "(a)" insert "(1)"; in the same line, strike "The health officer for a" and substitute "EACH"; strike beginning with "be" in line 17 down through "Secretary" in line 18 and substitute "HIRE A HEALTH OFFICER AS A CONTRACTUAL EMPLOYEE WHO MAY BE REMOVED IN ACCORDANCE WITH SUBSECTION (F) OF THIS SECTION"; after line 18, insert:

"(2) THE DURATION OF A CONTRACT FOR A HEALTH OFFICER SHALL COINCIDE WITH THE ELECTION CYCLE, AS DEFINED IN § 1–101 OF THE ELECTION ARTICLE.";

in line 19, strike "(1)"; and strike in their entirety lines 21 through 23, inclusive.

On page 2 of the bill, strike in their entirety lines 1 through 8, inclusive; in line 9, strike "(d)" and substitute "(C)"; in line 19, strike "(e)" and substitute "(D)"; in the same line, strike "taking office" and substitute "STARTING WORK UNDER A

<u>CONTRACT</u>"; in the same line, strike "appointee to the office of" and substitute "<u>INDIVIDUAL HIRED AS THE</u>"; in line 20, strike "required by" and substitute "<u>IN</u>"; in line 23, strike "(F)" and substitute "(E)"; in the same line, after "The" insert "<u>CONTRACT</u> <u>OF</u>"; strike "removed from office" and substitute "<u>TERMINATED</u>".

On page 3 of the bill, in line 26, after "**HEARINGS**." insert:

"3–304.

(b) Except as otherwise provided by law, each health officer is a [special appointment] STATE EMPLOYEE in the State Personnel Management System.".

On page 1 of the Health and Government Operations Committee Amendments, in Amendment No. 2, strike beginning with "<u>Article</u>" in line 5 down through "<u>service.</u>" in line 10.
