(12) IF THE ADULT HAS A FULLY EXECUTED POWER OF ATTORNEY, ADVANCE DIRECTIVE, OR REVOCABLE TRUST AGREEMENT AND THE ADULT DOES NOT EXPRESSLY OBJECT, DELIVER A COPY OF THE SUPPORTED DECISION– MAKING AGREEMENT TO THE AGENT DESIGNATED UNDER THE POWER OF ATTORNEY OR ADVANCE DIRECTIVE OR ANY TRUSTEE UNDER THE REVOCABLE TRUST AGREEMENT".

On page 8, strike beginning with "WHO" in line 9 down through "AGREEMENT" in line 12; in line 14, strike "COMPLYING" and substitute "IF THE THIRD PARTY ACTED IN GOOD FAITH RELIANCE ON A DECISION MADE BY AN ADULT UTILIZING A SUPPORTED DECISION-MAKING AGREEMENT, COMPLYING"; in line 15, strike "BASED ON AN" and substitute "OR OTHERWISE COMPLYING WITH A SUPPORTED DECISION-MAKING AGREEMENT BASED ON A GOOD FAITH"; in line 18, after "DECLINING" insert "TO HONOR A DECISION MADE BY AN ADULT UTILIZING A SUPPORTED DECISION-MAKING AGREEMENT OR FAILING"; and in line 19, strike "ACTUAL KNOWLEDGE" and substitute "<u>A REASONABLE GOOD FAITH BELIEF</u>".
