2 **Cybersecurity Scholarship Program – Alterations and Maryland Cybersecurity**  
3 **~~Loan Assistance Repayment Program Establishment~~**

4 FOR the purpose of altering certain criteria for the Cybersecurity Public Service  
5 Scholarship Program, including increasing the number of years a recipient may hold  
6 an award, expanding the qualifying positions for a scholarship recipient to fulfill a  
7 work obligation, and establishing criteria for part-time students to be eligible for the  
8 scholarship, hold an award, and fulfill a work obligation; requiring the State  
9 Department of Education to provide information on the Program to high school  
10 students who participate in career and technology programs related to cybersecurity;  
11 ~~establishing the Maryland Cybersecurity Loan Assistance Repayment Program;~~ and  
12 generally relating to the Cybersecurity Public Service Scholarship Program ~~and the~~  
13 ~~Maryland Cybersecurity Loan Assistance Repayment Program.~~

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
 23 That the Laws of Maryland read as follows:

24 **Article – Education**

28 (a) In this subtitle the following words have the meanings indicated.

29 (b) “Eligible institution” means a public or private nonprofit institution of higher  
 30 education in the State that:

31 (1) Possesses a certificate of approval from the Commission; or

32 (2) Is approved under operation of law.

33 (c) ~~“HIGHER EDUCATION LOAN” MEANS A LOAN OBTAINED FOR TUITION,~~  
 34 ~~EDUCATION EXPENSES, OR LIVING EXPENSES FOR COMMUNITY COLLEGE,~~

1 ~~UNDERGRADUATE OR GRADUATE STUDY, OR A NONDEGREE CERTIFICATION OR~~  
 2 ~~APPRENTICESHIP PROGRAM, THAT LEADS TO A DEGREE, REGISTERED~~  
 3 ~~APPRENTICESHIP, OR CERTIFICATION IN CYBERSECURITY.~~

4 ~~(D)~~ (c) “Program” means the Cybersecurity Public Service Scholarship  
 5 Program.

6 ~~(E) “REPAYMENT PROGRAM” MEANS THE MARYLAND CYBERSECURITY~~  
 7 ~~LOAN ASSISTANCE REPAYMENT PROGRAM.~~

9 (a) There is a scholarship program known as the Cybersecurity Public Service  
 10 Scholarship Program in the State.

11 (b) The purpose of the Program is to support students who are pursuing an  
 12 education in programs that are directly relevant to cybersecurity.

13 18–3503.

14 (a) The Office shall administer the Program.

15 (b) An individual may apply to the Office for a scholarship under this subtitle if  
 16 the individual:

17 (1) Is eligible for in-State tuition;

18 (2) **[Is] EXCEPT AS PROVIDED IN SUBSECTION (F) OF THIS SECTION,**  
 19 **IS** a student who **[is]:**

20 **(I) IS** enrolled full-time at an eligible institution in an approved  
 21 degree or certificate program that is directly relevant to cybersecurity; **AND**

22 **[(3)] (II)** Is within **[2] 3** years of graduation from the individual’s degree  
 23 or certificate program;

24 **[(4)] (3)** Has maintained a cumulative grade point average of at least 3.0  
 25 on a 4.0 scale; and

26 **[(5)] (4)** (i) Has not received a federal CyberCorps Scholarship for  
 27 Service; or

28 (ii) Has applied for but has not received a federal CyberCorps  
 29 Scholarship for Service.

1 (c) A scholarship award under this subtitle may be used at any eligible institution  
2 to pay for education expenses as defined by the Office, including:

3 (1) Tuition and mandatory fees; and

4 (2) Room and board.

5 (d) A scholarship recipient shall maintain a grade point average of at least 3.0 on  
6 a 4.0 scale.

7 (e) **[Each] EXCEPT AS PROVIDED IN SUBSECTION (F) OF THIS SECTION,**  
8 **EACH** recipient of a scholarship under this subtitle may hold the award for **[2] 3** years of  
9 full-time study.

10 **(F) (1) BEGINNING WITH THE 2023–2024 PROGRAM APPLICATION**  
11 **PERIOD, A PART–TIME STUDENT MAY APPLY TO THE OFFICE FOR A SCHOLARSHIP**  
12 **UNDER THIS SUBTITLE IN ACCORDANCE WITH REGULATIONS ADOPTED BY THE**  
13 **OFFICE.**

14 **(2) EACH RECIPIENT OF A SCHOLARSHIP UNDER THIS SUBTITLE MAY**  
15 **HOLD THE AWARD FOR 6 YEARS IF THE RECIPIENT:**

16 **(I) IS A PART–TIME STUDENT;**

17 **(II) CONTINUES TO BE ELIGIBLE FOR IN–STATE TUITION UNDER**  
18 **THIS ARTICLE; AND**

19 **(III) CONTINUES TO BE A STUDENT AT THE INSTITUTION AND**  
20 **TAKES AT LEAST 6 SEMESTER HOURS OF COURSES EACH SEMESTER LEADING TO A**  
21 **DEGREE OR CERTIFICATE THAT IS DIRECTLY RELEVANT TO CYBERSECURITY.**

22 **(3) THE OFFICE SHALL DETERMINE AN AWARD AMOUNT THAT IS**  
23 **APPROPRIATELY PRORATED FOR THE PART–TIME STATUS OF THE STUDENT.**

24 **(4) ON OR BEFORE JANUARY 1, 2023, THE OFFICE SHALL ADOPT**  
25 **REGULATIONS TO ADMINISTER THE PROGRAM FOR PART–TIME STUDENTS.**

26 **(G) THE DEPARTMENT SHALL PROVIDE INFORMATION ON THE PROGRAM**  
27 **TO HIGH SCHOOL STUDENTS WHO PARTICIPATE IN CAREER AND TECHNOLOGY**  
28 **EDUCATION PROGRAMS RELATED TO CYBERSECURITY.**

1 (a) (1) [For] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS  
 2 SUBSECTION, FOR 1 year for each year that the recipient receives a scholarship under this  
 3 subtitle, a scholarship recipient shall:

4 [(1)] (I) Work [for a unit of State government] IN THE STATE in the  
 5 cybersecurity field FOR A:

6 1. A. LOCAL EDUCATION AGENCY;

7 B. PUBLIC HIGH SCHOOL; OR

8 C. COMMUNITY COLLEGE; OR

9 2. UNIT OF:

10 A. STATE GOVERNMENT;

11 B. COUNTY GOVERNMENT; OR

12 C. CITY OR MUNICIPAL GOVERNMENT; or

13 [(2)] (II) Teach [in a public high school] in the State in an education  
 14 program that is directly relevant to cybersecurity IN:

15 1. A PUBLIC HIGH SCHOOL; OR

16 2. A COMMUNITY COLLEGE.

17 (2) (I) ~~SUBJECT TO SUBPARAGRAPH (II)~~ SUBPARAGRAPHS (II) AND  
 18 (III) OF THIS PARAGRAPH, THE OFFICE SHALL ADOPT ~~REGULATIONS~~ GUIDELINES  
 19 ON OR BEFORE JANUARY 1, 2023, ESTABLISHING A WORK OBLIGATION,  
 20 APPROPRIATELY PRORATED, FOR A SCHOLARSHIP RECIPIENT WHO RECEIVES A  
 21 SCHOLARSHIP AS A PART-TIME STUDENT.

22 (II) THE WORK OBLIGATION FOR A PART-TIME STUDENT SHALL  
 23 EQUAL THE AMOUNT OF TIME NEEDED FOR AN EQUIVALENT FULL-TIME STUDENT TO  
 24 COMPLETE THE CERTIFICATION.

25 (III) THE WORK OBLIGATION FOR A PART-TIME STUDENT MAY  
 26 NOT EXCEED 3 YEARS.

27 (b) In accordance with § 18-112 of this title, a scholarship recipient shall repay  
 28 the Commission the funds received under this subtitle if the recipient does not:

1           (1) Earn credit as a full-time student as defined in regulations adopted by  
2 the Office for the Program **OR AS A PART-TIME STUDENT AS REQUIRED IN § 18-3503(F)**  
3 **OF THIS SUBTITLE;**

4           (2) Complete an approved degree **OR CERTIFICATE** program that is  
5 directly relevant to cybersecurity at an eligible institution; and

6           (3) Perform the work obligation required under subsection (a) of this  
7 section.

8           (c) Except as otherwise provided in this section, a recipient shall begin repayment  
9 at any time during the period that the recipient is no longer performing the work obligation  
10 required under subsection (a) of this section.

11           (d) Except as otherwise provided in this section, repayment shall be made to the  
12 State within 6 years after the repayment period begins and shall follow a repayment  
13 schedule established by the Office.

14           (e) The Office may waive or defer repayment in the event of disability or extended  
15 sickness that prevents the recipient from fulfilling the work obligation required under  
16 subsection (a) of this section.
