(a) Except as provided in subsection (b) of this section, a person may not attire or
 equip an individual, or permit an individual to be attired or equipped, in a manner which
 creates the appearance that the individual is performing an official or governmental
 function in connection with an election, including:

AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three–fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
