- 3 FOR the purpose of establishing a tax-free period each year during which the purchase of
- 4 winter weather clothing, footwear, and accessories is exempt from the sales and use
- 5 tax, subject to certain limitations; and generally relating to a sales and use tax
- 6 exemption for winter weather shopping.

- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 13 That the Laws of Maryland read as follows:
- 14 Article Tax General
- 15 **11–228.1.**
- 16 (A) IN THIS SECTION, "ACCESSORY ITEMS" INCLUDES HATS, SCARVES, AND
- 17 GLOVES.
- 18 (B) THIS SECTION SHALL APPLY TO THE SALE OF WINTER COATS, WINTER
- 19 FOOTWEAR, AND WINTER WEATHER ACCESSORY ITEMS FOR THE USE OF ANY
- 20 STUDENT IN A SCHOOL IN THE STATE, INCLUDING AN INSTITUTION OF HIGHER
- 21 EDUCATION.
- 22 (C) (1) BEGINNING IN CALENDAR YEAR 2022, THE 14-DAY PERIOD FROM

- 1 THE FIRST SUNDAY AFTER THANKSGIVING DAY THROUGH THE SECOND FOLLOWING
- 2 SATURDAY SHALL BE A TAX-FREE PERIOD FOR WINTER WEATHER SHOPPING FOR
- 3 STUDENTS IN THE STATE, DURING WHICH THE EXEMPTION UNDER PARAGRAPH (2)
- 4 OF THIS SUBSECTION SHALL APPLY.
- 5 (2) DURING THE TAX-FREE PERIOD FOR WINTER WEATHER
- 6 SHOPPING ESTABLISHED UNDER PARAGRAPH (1) OF THIS SUBSECTION, THE SALES
- 7 AND USE TAX DOES NOT APPLY TO THE SALE OF ANY WINTER COAT OR ITEM OF
- 8 WINTER FOOTWEAR, EXCLUDING ACCESSORY ITEMS, IF THE TAXABLE PRICE OF THE
- 9 COAT OR ITEM OF FOOTWEAR IS \$100 OR LESS.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2022.
