CHAPTER _____

1 AN ACT concerning

2 ~~State Personnel – Professional Service~~ Correctional Education – Juvenile
3 Services Education Teachers Program and Correction Education Teachers

4 FOR the purpose of providing that certain teachers employed by the Department of
5 Juvenile Services and the Maryland Department of Labor are in the professional
6 service in the State Personnel Management System; requiring the Director of
7 Education and Workforce Skills Training for Correctional Institutions to set certain
8 qualification standards for certain teachers; clarifying that the Juvenile Services
9 Education Program is a public agency under certain provisions of law; and generally
10 relating to ~~the State Personnel Management System~~ education in correctional
11 facilities.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 Article – Education

19 7–1101.

20 (a) In this subtitle the following terms have the meanings indicated.

21 (e) “Public agency” means the Department, a local school system, THE JUVENILE
22 SERVICES EDUCATION PROGRAM, the Maryland School for the Deaf, or the Maryland
23 School for the Blind.

24 8–412.

25 (a) (1) In this section the following words have the meanings indicated.

26 (7) (i) “Public agency” includes the State Department of Education,
27 local education agencies, and other agencies that are responsible for providing education to
28 a child with a disability, including the Maryland Department of Health, the Behavioral
29 Health Administration, the Developmental Disabilities Administration, the [Department
30 of Juvenile Services] JUVENILE SERVICES EDUCATION PROGRAM, the Maryland
31 School for the Deaf, the Maryland Department of Labor, and the Department of Public
32 Safety and Correctional Services.

33 (ii) For the purpose of this section, the Maryland School for the Blind
34 shall be considered a public agency.

35 8–413.

1 (a) (1) In this section the following words have the meanings indicated.

2 (6) “Public agency” means the State Department of Education, a local
3 school system, THE JUVENILE SERVICES EDUCATION PROGRAM, or any State agency
4 responsible for providing education to students with disabilities, including the Maryland
5 School for the Blind and the Maryland School for the Deaf.

6 Article – Human Services

7 9–602.

8 There is a Juvenile Services Education Program within the Department.

9 9–603.

10 (a) (1) Beginning July 1, 2022, the Department and the Board, subject to the
11 memorandum of understanding, jointly shall have the authority and responsibility for
12 implementing the juvenile services educational programs in the State.

13 (2) The Superintendent shall provide and oversee educational services to
14 all juveniles in a residential facility.

15 (b) The Superintendent shall implement for each residential facility an
16 educational program as approved by the Board that:

17 (1) meets the special needs and circumstances of the juveniles in the
18 residential facility; and

19 (2) is accredited by an approved accrediting agency.

20 (c) (1) The Department, subject to the memorandum of understanding, shall
21 employ any staff necessary to carry out the Juvenile Services Education Program as
22 provided in the State budget.

23 (2) Educational staff in the Department shall be subject to the career
24 ladder and salary provisions under Title 6, Subtitle 10 of the Education Article.

25 (3) **EACH NOTWITHSTANDING ANY OTHER PROVISIONS OF LAW, EACH**
26 **TEACHER IN THE JUVENILE SERVICES EDUCATION PROGRAM WHO IS EMPLOYED BY**
27 **THE DEPARTMENT IS IN THE PROFESSIONAL SERVICE IN THE STATE PERSONNEL**
28 **MANAGEMENT SYSTEM.**

29 (d) The Department shall adopt regulations to carry out the requirements of this
30 section.

1 (e) The Board may authorize the Department to contract with a nonprofit private
 2 party or a county board of education to provide educational services for juveniles in a
 3 residential facility.

4 (f) For fiscal year 2023 and each fiscal year thereafter, the Governor shall include
 5 in the annual budget bill an appropriation in an amount sufficient to meet the requirements
 6 of this subtitle.

7 Article – Labor and Employment

8 11–903.

9 (a) The Department is responsible for the provision of education and workforce
 10 skills training programs in the adult correctional institutions in the State.

11 (b) The Secretary shall appoint a Director of Education and Workforce Skills
 12 Training for Correctional Institutions.

13 (c) The Director shall receive the salary provided in the budget of the
 14 Department.

15 (d) The Director shall:

16 (1) implement and operate the educational and workforce skills training
 17 programs developed by the Council in the correctional institutions;

18 (2) meet with and advise the Council about the programs; ~~and~~

19 (3) consult with the Commissioner of Correction and the warden of each
 20 institution about the operation of the programs; AND

21 **(4) SET QUALIFICATION STANDARDS FOR TEACHERS IN WORKFORCE**
 22 **SKILLS TRAINING PROGRAMS WHO ARE EMPLOYED BY THE DEPARTMENT THAT ARE**
 23 **SIMILAR TO THE STANDARDS FOR TEACHERS PROVIDING CTE INSTRUCTION IN**
 24 **ACCORDANCE WITH § 7–205.1 OF THE EDUCATION ARTICLE.**

25 **(E) EACH NOTWITHSTANDING ANY OTHER PROVISIONS OF LAW, EACH**
 26 **TEACHER IN AN EDUCATIONAL AND WORKFORCE SKILLS TRAINING PROGRAM WHO**
 27 **IS EMPLOYED BY THE DEPARTMENT IS IN THE PROFESSIONAL SERVICE IN THE**
 28 **STATE PERSONNEL MANAGEMENT SYSTEM.**

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
 30 1, 2022.
