1 AN ACT concerning

2 **Equity in Transportation Sector – Guidelines and Analyses**

3 FOR the purpose of requiring that equity be considered when certain State transportation
4 plans, reports, and goals are developed; altering the membership of the advisory
5 committee on State transportation goals, benchmarks, and indicators; ~~establishing~~
6 ~~the Commission on Transportation Equity~~; requiring the Department of
7 Transportation, in collaboration with the Maryland Transit Administration, to
8 conduct certain analyses and consult with certain communities before announcing
9 or proposing certain service changes; requiring the Administration to take certain
10 actions to avoid or minimize certain disparate impacts or disproportionate burdens;
11 requiring the Administration to compile a report on the impacts of a proposed service
12 change after holding a public hearing on the proposed service change; requiring the
13 Department, in collaboration with the Administration, to conduct certain analyses
14 and consult with certain communities before announcing any reduction or
15 cancellation of a capital expansion project in the construction program of the
16 Consolidated Transportation Program; requiring the Administration to compile a
17 report on the impacts of a proposed reduction or cancellation of a capital expansion
18 project in the construction program of the Consolidated Transportation Program;
19 and generally relating to equity in transportation.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 13 That the Laws of Maryland read as follows:

16 (d) (1) The Maryland Transportation Plan shall:

17 [(1)] (I) Except as otherwise provided, be revised every 5 years through
 18 an inclusive public participation process;

19 [(2)] (II) Include a 20–year forecast of State transportation needs, based
 20 on the financial resources anticipated to be available to the Department during that
 21 20–year period;

22 [(3)] (III) Be expressed in terms of the State transportation goals and
 23 measures; and

24 [(4)] (IV) Include a summary of the types of projects and programs that are
 25 proposed to accomplish the State transportation goals and measures, using a multi–modal
 26 approach when feasible.

27 (2) **BEGINNING WITH THE 2045 MARYLAND TRANSPORTATION PLAN,**
 28 **THE DEPARTMENT SHALL CONSIDER WAYS TO ACHIEVE EQUITY IN THE**
 29 **TRANSPORTATION SECTOR WHEN DEVELOPING THE STATE TRANSPORTATION**
 30 **GOALS.**

31 (g) Beginning with the year 2002 State Report on Transportation and continuing
 32 thereafter, before the General Assembly considers the proposed Maryland Transportation
 33 Plan and the proposed Consolidated Transportation Program, the Department shall submit
 34 an annual report on the attainment of State transportation goals and benchmarks for the

1 approved and proposed Maryland Transportation Plan and the approved and proposed
 2 Consolidated Transportation Program to the Governor and, subject to § 2–1257 of the State
 3 Government Article, to the General Assembly.

4 (h) (1) The report required under subsection (g) of this section shall include:

5 (i) The establishment of certain measurable performance indicators
 6 or benchmarks, in priority funding areas at a minimum, designed to quantify the State
 7 transportation goals and measures specified in the Maryland Transportation Plan and §
 8 2–103.7 of this subtitle; and

9 (ii) The degree to which the projects and programs contained in the
 10 approved Maryland Transportation Plan and Consolidated Transportation Program attain
 11 those goals and benchmarks as measured by the performance indicators or benchmarks.

12 (2) The Department shall include in its report measurable long–term goals,
 13 and intermediate benchmarks of progress toward the attainment of the long–term goals,
 14 for the following measurable transportation indicators:

15 (i) An increase in the share of total person trips for each of transit,
 16 high occupancy auto, pedestrian, and bicycle modes of travel;

17 (ii) A decrease in indicators of traffic congestion as determined by
 18 the Department; and

19 (iii) Any other performance goals established by the Department for
 20 reducing automobile traffic and increasing the use of nonautomobile traffic.

5 (i) The Smart Growth Subcabinet, established under Title 9, Subtitle 14 of the
 6 State Government Article, shall conduct an annual review of the State transportation goals,
 7 benchmarks, and indicators.

8 (j) (1) An advisory committee shall be assembled to advise the Department on
 9 the State transportation goals, benchmarks, and indicators under subsection (h) of this
 10 section.

11 (2) Membership of the advisory committee shall include but is not limited
 12 to the following members appointed by the Governor:

- 13 (i) A representative of the Maryland business community;
- 14 (ii) A representative of the disabled citizens community;
- 15 (iii) A representative of rural interests;
- 16 (iv) A representative of an auto users group;
- 17 (v) A representative of a transit users group;

- 23 (ix) A nationally recognized expert on transportation performance
 24 measurement;
- 25 (x) A representative of an environmental advocacy organization;
- 26 (xi) A representative from the Maryland Department of Planning;
- 27 (xii) A representative of the Maryland Association of Counties; [and]
- 28 (xiii) A representative of the Maryland Municipal League;

1 (XIV) A REPRESENTATIVE OF THE MARYLAND STATE
2 CONFERENCE OF THE NATIONAL ASSOCIATION FOR THE ADVANCEMENT OF
3 COLORED PEOPLE; AND

4 (XV) A REPRESENTATIVE OF A TRANSPORTATION LABOR
5 ORGANIZATION, DESIGNATED BY THE MARYLAND STATE AND DISTRICT OF
6 COLUMBIA AFL-CIO.

7 (3) The Governor shall appoint the chairman of the advisory committee.

8 (4) The advisory committee shall meet at least four times during the
9 process of developing the Maryland Transportation Plan to provide advice to the
10 Department on meeting the requirements of this subsection.

11 (5) The Department and the advisory committee shall consider the
12 following:

13 (i) Transportation and population trends and their impact on the
14 State's transportation system and priority funding areas;

15 (ii) Past and present State funding devoted to the various
16 transportation modes and demand management;

17 (iii) The full range of unmet transportation needs in priority funding
18 areas;

19 (iv) The full range of transportation measures and facilities
20 available, and their role, effectiveness, and cost effectiveness in providing travel choices
21 and reducing congestion;

22 (v) A review of transportation performance indicators and their use
23 in other states;

24 (vi) A review of the coordination of State transportation investments
25 with local growth plans for priority funding areas;

26 (vii) The types of investments needed and their levels of funding for
27 supporting the State transportation goals and measures established under § 2-103.7 of this
28 subtitle;

29 (viii) The impact of transportation investment on:

30 1. The environment;

31 2. Environmental justice as defined in § 1-701 of the
32 Environment Article;

1 3. Communities; [and]

2 4. Economic development; [and]

3 5. **RACIAL EQUITY; AND**

4 6. **PERSONS TO THE EXTENT DATA IS AVAILABLE,**
 5 **PERSONS WITH DISABILITIES, INCLUDING SERVICE ACCESSIBILITY; AND**

6 (ix) The Climate Action Plan goals required by the Greenhouse Gas
 7 Emissions Reduction Act of 2009 under § 2–1205(b) of the Environment Article.

12 (D) **“DISPARATE IMPACT” MEANS A FACIALLY NEUTRAL POLICY OR**
 13 **PRACTICE THAT DISPROPORTIONATELY AFFECTS MEMBERS OF A GROUP**
 14 **IDENTIFIED BY RACE, COLOR, OR NATIONAL ORIGIN, WHERE THE RECIPIENT’S**
 15 **POLICY OR PRACTICE LACKS A SUBSTANTIAL LEGITIMATE JUSTIFICATION AND**
 16 **WHERE THERE EXIST ONE OR MORE ALTERNATIVES THAT WOULD SERVE THE SAME**
 17 **LEGITIMATE OBJECTIVES BUT WITH LESS DISPROPORTIONATE EFFECT ON THE**
 18 **BASIS OF RACE, COLOR, OR NATIONAL ORIGIN.**

19 (E) **“DISPROPORTIONATE BURDEN” MEANS A FACIALLY NEUTRAL POLICY**
 20 **OR PRACTICE THAT DISPROPORTIONATELY AFFECTS LOW-INCOME POPULATIONS**
 21 **MORE THAN NON-LOW-INCOME POPULATIONS AND, ON A FINDING OF**
 22 **DISPROPORTIONATE BURDEN, REQUIRES THE RECIPIENT TO EVALUATE**
 23 **ALTERNATIVES AND MITIGATE BURDENS WHERE PRACTICABLE.**

24 [(d)] (F) “District” means:

25 (1) The Metropolitan Transit District, consisting of Baltimore City,
 26 Baltimore County, Anne Arundel County, and other areas as designated by the Secretary
 27 after consultation and coordination with the affected jurisdiction and subject to the
 28 provisions of the Washington Metropolitan Transit Authority Compact; and

29 (2) Any area in which railroad service is performed under contract with the
 30 Administration or in which railroad facilities are owned by the Administration.

1 **[(e)] (G)** “Excursion train” means any special event train sponsored or
2 contracted for in connection with the promotion of a public event benefiting the State and
3 its citizens.

4 **[(f)] (H)** “Light rail transit” means rail transit which is electrically powered and
5 can operate in mixed traffic with automobiles.

6 **[(g)] (I)** “Private carrier” means any person that renders transit service within
7 the District under an operating permit or license issued by an agency of this State
8 exercising regulatory jurisdiction over transportation of passengers within this State and
9 over persons engaged in that business.

10 **[(h)] (J)** “Proof of fare payment” means evidence of fare prepayment authorized
11 by the Administration for the use of transit service.

12 **[(i)] (K)** “Railroad company” means any entity engaged in the providing of
13 railroad service under this title.

14 **[(j)] (L)** (1) “Railroad facility” means any facility used in providing railroad
15 services, and includes any one or more or combination of:

16 (i) Switches, spurs, tracks, structures, terminals, yards, real
17 property, and other facilities useful or designed for use in connection with the
18 transportation of persons or goods by rail; and

19 (ii) All other appurtenances, including locomotives, cars, vehicles,
20 and other instrumentalities of shipment or carriage, useful or designed for use in
21 connection with the transportation of persons or goods by rail.

22 (2) “Railroad facility” does not include any transit facility.

23 **[(k)] (M)** “Railroad service” means any service utilizing rail or railroad facilities
24 performed by any common carrier operating under the jurisdiction of the State or federal
25 government as a common carrier and includes any such service performed by the National
26 Railroad Passenger Corporation.

27 **[(l)] (N)** “Transit facility” includes any one or more or combination of tracks,
28 rights-of-way, bridges, tunnels, subways, rolling stock, stations, terminals, ports, parking
29 areas, equipment, fixtures, buildings, structures, other real or personal property, and
30 services incidental to or useful or designed for use in connection with the rendering of
31 transit service by any means, including rail, bus, motor vehicle, or other mode of
32 transportation, but does not include any railroad facility.

33 **[(m)] (O)** “Transit-oriented development” means a mix of private or public
34 parking facilities, commercial and residential structures, and uses, improvements, and
35 facilities customarily appurtenant to such facilities and uses, that:

1 (1) Is part of a deliberate development plan or strategy involving:

2 (i) Property that is adjacent to the passenger boarding and alighting
3 location of a planned or existing transit station; or

4 (ii) Property, any part of which is located within one-half mile of the
5 passenger boarding and alighting location of a planned or existing transit station;

6 (2) Is planned to maximize the use of transit, walking, and bicycling by
7 residents and employees; and

8 (3) Is designated as a transit-oriented development by:

9 (i) The Secretary, after considering a recommendation of the Smart
10 Growth Subcabinet established under § 9-1406 of the State Government Article; and

11 (ii) The local government or multicounty agency with land use and
12 planning responsibility for the relevant area.

13 **[(n)] (P)** (1) “Transit service” means the transportation of persons and their
14 packages and baggage and of newspapers, express, and mail in regular route, special, or
15 charter service by means of transit facilities between points within the District.

16 (2) “Transit service” does not include any:

17 (i) Vanpool operation; or

18 (ii) Railroad service.

19 **[(o)] (Q)** (1) “Transit station” means any facility, the primary function of
20 which relates to the boarding and alighting of passengers from transit vehicles.
