CHAPTER _____

1 AN ACT concerning

Landlord and Tenant – Repossession for Failure to Pay Rent – Registration and License Information

4 FOR the purpose of requiring a landlord, or a landlord's duly authorized agent, at the time $\mathbf{5}$ of filing a certain complaint in an action for repossession for failure to pay rent to 6 submit certain original or electronic copies of documents in order to prove, by a 7 certain standard of evidence, plead and demonstrate that a property is in compliance 8 with, or exempt from, certain local license requirements and certain lead-based 9 paint abatement laws; specifying that a certain provisional or temporary license is 10 insufficient to satisfy certain filing requirements; establishing that information 11 regarding the status of a rental property as an affected property under certain lead-based paint abatement laws may be an issue of fact at trial; establishing that 12a landlord may provide an electronic copy of a certain license as proof of compliance 13 with certain local license requirements; prohibiting a court from entering a judgment 14 in favor of a landlord who fails to prove that a property is in compliance with, or 1516 exempt from, certain local license requirements; and generally relating to actions for 17repossession for failure to pay rent.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

shall be lawful for the landlord to have again and repossess the premises in accordance
with this section.

1 (iv) In the case of a residential tenancy, the court may also give 2 judgment in favor of the landlord for the amount of rent and late fees determined to be due 3 together with costs of the suit if the court finds that the residential tenant was personally 4 served with a summons.

5 (v) In the case of a nonresidential tenancy, if the court finds that 6 there was such service of process or submission to the jurisdiction of the court as would 7 support a judgment in contract or tort, the court may also give judgment in favor of the 8 landlord for:

1. The amount of rent and late fees determined to be due;

2. Costs of the suit; and

11 3. Reasonable attorney's fees, if the lease agreement 12 authorizes the landlord to recover attorney's fees.

13 (vi) A nonresidential tenant who was not personally served with a 14 summons shall not be subject to personal jurisdiction of the court if that tenant asserts that 15 the appearance is for the purpose of defending an in rem action prior to the time that 16 evidence is taken by the court.

17 (3) The court, when entering the judgment, shall also order that possession 18 of the premises be given to the landlord, or the landlord's agent or attorney, within 4 days 19 after the trial.

20 (4) The court may, upon presentation of a certificate signed by a physician 21 certifying that surrender of the premises within this 4-day period would endanger the 22 health or life of the tenant or any other occupant of the premises, extend the time for 23 surrender of the premises as justice may require but not more than 15 days after the trial.

(5) However, if the tenant, or someone for the tenant, at the trial, or adjournment of the trial, tenders to the landlord the rent and late fees determined by the court to be due and unpaid, together with the costs of the suit, the complaint against the tenant shall be entered as being satisfied.

10 (b) (1) In any action of summary ejectment for failure to pay rent where the 11 landlord is awarded a judgment giving him restitution of the leased premises, the tenant 12 has the right to redemption of the leased premises by tendering in cash, certified check or 13 money order to the landlord or his agent all past due rent and late fees, plus all court 14 awarded costs and fees, at any time before actual execution of the eviction order.

15 (2) The right of redemption is not available to a tenant if the landlord 16 alleges and shows that more than three judgments of restitution were issued against the 17 tenant in the 12 months preceding the filing of the landlord's complaint.

18 (3) Nothing in this section shall preclude a tenant in any summary 19 ejectment action from raising any defense available under the Public Local Laws of 20 Baltimore City. If a tenant prevails on any of these defenses, the judgment, whether or not 21 it includes a judgment of restitution against the tenant, shall not be considered a judgment 22 of restitution for purposes of paragraph (2) of this subsection.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 24 January 1, 2023.
