3 FOR the purpose of altering the education requirements that an applicant for licensure by
4 the State Acupuncture Board must achieve to be issued a license; and generally
5 relating to the State Acupuncture Board.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

13 **Article – Health Occupations**

14 1A–302.

15 (a) To qualify for a license, an applicant shall be an individual who meets the
16 requirements of this section.

17 (b) The application shall:

7 C. FOUND BY THE BOARD TO BE EQUIVALENT TO A
8 COURSE APPROVED OR ACCREDITED UNDER ITEM A OR B OF THIS ITEM; AND

9 2. ACHIEVEMENT OF A PASSING SCORE ON AN
10 EXAMINATION GIVEN BY THE NATIONAL CERTIFICATION COMMISSION FOR
11 ACUPUNCTURE AND ORIENTAL MEDICINE OR DETERMINED BY THE BOARD TO BE
12 EQUIVALENT TO THE EXAMINATION GIVEN BY THE NATIONAL CERTIFICATION
13 COMMISSION FOR ACUPUNCTURE AND ORIENTAL MEDICINE;

14 (4) Demonstrate the ability to communicate in the English language; and

15 (5) Meet any other qualifications that the Board establishes in regulations.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2022.
