2 Marine Contractor License – Performance of Services – Licensing 3 <u>Authorization,</u> Requirements, and Fees

FOR the purpose of authorizing a unit of local government to qualify for a marine contractor 4 5 license; exempting an individual employed by a county or municipality in the State 6 who performs marine contractor services while in the performance of the duties of 7 their employment from paying a fee for the issuance or renewal of a marine 8 contractor license or a test administered by the Marine Contractors Licensing Board; 9 authorizing an individual employed by a county or municipality in the State to 10 perform marine contractor services while in the performance of the duties of their 11 employment without having to obtain a marine contractor license under certain 12 circumstances; and generally relating to marine contractor licenses and fees.
