#### AN ACT concerning 1

#### $\mathbf{2}$ Health Occupations - State Board of Massage Therapy Examiners - Requiring 3 License to Practice and Other Revisions

FOR the purpose of requiring the State Board of Massage Therapy Examiners to maintain 4 on the Board's website an electronic roster of individuals registered and licensed to  $\mathbf{5}$ 6 practice massage therapy; repealing a requirement for the Board to adopt an official 7 seal; phasing out the option for an individual to be registered by the Board to practice 8 massage therapy in a setting that is not a health care setting; altering the 9 educational requirements for licensure or registration as a massage therapist; 10 providing that an individual who practices, attempts to practice, or offers to practice 11 as a massage therapist without being licensed or registered by the Board to practice massage therapy is subject to a civil fine to be paid into the State Board of Massage 12Therapy Examiners Fund; and generally relating to massage therapists. 13

5 (a) A person who practices or attempts to practice massage therapy without a 6 license or registration in violation of § 6–501 of this subtitle or represents to the public in 7 violation of § 6–502 of this subtitle that the person is authorized to practice massage 8 therapy is guilty of a misdemeanor and on conviction is subject to:

9 (1) For a first offense, a fine not exceeding \$2,000 or imprisonment not 10 exceeding 6 months; or
