A BILL ENTITLED

1 AN ACT concerning

2 **Montgomery County – Board of Education – Student Member Scholarship**

3 **MC 05–22**

4 FOR the purpose of altering the scholarship award for a student member of the
5 Montgomery County Board of Education who completes a full term on the county
6 board to be equal to certain costs for a resident undergraduate student to attend a
7 certain institution within the University System of Maryland during the academic
8 year in which the student member serves on the county board; and generally relating
9 to the scholarship for the student member of the Montgomery County Board of
10 Education.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Education**

19 3–902.

20 (a) An elected member of the county board is entitled to reimbursement for travel
21 and other expenses as provided by the Montgomery County Council.

22 (b) (1) An elected member of the county board is entitled to receive:

23 (i) \$25,000 annually as compensation; or

1 (ii) An annual salary set through legislation based on the
2 recommendations of the Montgomery County Board of Education Compensation
3 Commission in accordance with Title 28, Subtitle 1A of the Local Government Article.

4 (2) The president of the county board is entitled to receive:

5 (i) \$29,000 annually as compensation; or

6 (ii) An annual salary set through legislation based on the
7 recommendations of the Montgomery County Board of Education Compensation
8 Commission in accordance with Title 28, Subtitle 1A of the Local Government Article.

9 (3) An elected member is entitled to health insurance and to other fringe
10 benefits regularly provided to employees of the board of education under the same terms
11 and conditions extended to other employees of the board of education.

12 (c) (1) The student member may not receive compensation but, after
13 submitting expense vouchers, may be reimbursed for out-of-pocket expenses incurred in
14 connection with official duties.

15 (2) (I) A student member who completes a full term on the county board
16 shall be granted a scholarship [of:

17 (i) \$5,000 to be applied toward the student's higher education costs;
18 or

19 (ii) A scholarship set through legislation based on the
20 recommendations of the Montgomery County Board of Education Compensation
21 Commission in accordance with Title 28, Subtitle 1A of the Local Government Article] **TO**
22 **BE APPLIED TOWARD THE STUDENT'S HIGHER EDUCATION COSTS.**

23 **(II) THE SCHOLARSHIP AMOUNT IS EQUAL TO THE HIGHEST**
24 **ANNUAL RESIDENT UNDERGRADUATE TUITION, MANDATORY FEES, AND ROOM AND**
25 **BOARD THAT IS CHARGED AT A 4-YEAR PUBLIC INSTITUTION OF HIGHER EDUCATION**
26 **WITHIN THE UNIVERSITY SYSTEM OF MARYLAND, OTHER THAN THE UNIVERSITY OF**
27 **MARYLAND GLOBAL CAMPUS AND UNIVERSITY OF MARYLAND, BALTIMORE**
28 **CAMPUS, FOR THE ACADEMIC YEAR IN WHICH THE STUDENT MEMBER SERVES ON**
29 **THE COUNTY BOARD.**

30 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
31 1, 2022.
