6 (2) [\$99,500] **\$116,000** starting on the first anniversary after 7 appointment;

8 (3) [\$102,500] **\$118,500** starting on the second anniversary after 9 appointment; and

10 (4) [\$105,500] **\$120,000** starting on the third anniversary after 11 appointment and thereafter.

12SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35 13of the Maryland Constitution, this Act may not be construed to extend or apply to the salary 14or compensation of the Comptroller, Treasurer, Attorney General, or Secretary of State while serving in a term of office beginning before the effective date of this Act, but the 15provisions of this Act concerning the salary or compensation of the Comptroller, Treasurer, 16 17Attorney General, or Secretary of State shall take effect at the beginning of the next 18 following term of office. This limitation does not apply to an individual appointed or elected after the effective date of this Act to fill out an unexpired term. 19

20 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 21 October 1, 2022.
