 8 **SUBTITLE IS TO ATTRACT, RETAIN, AND ENCOURAGE COMMERCIAL DEVELOPMENT**
 9 **IN ECONOMICALLY DISTRESSED AREAS OF THE STATE, IN PARTNERSHIP WITH**
 10 **POLITICAL SUBDIVISIONS, BY INCENTIVIZING CAPITAL INVESTMENT AND JOB**
 11 **CREATION THROUGH REAL PROPERTY AND INCOME TAX CREDITS.**

12 **(B)** Subject to § 9–103 of the Tax – Property Article, a business entity that owns,
 13 operates, develops, constructs, or rehabilitates property intended for use primarily as single
 14 or multifamily residential property located in an enterprise zone may not benefit from an
 15 incentive or initiative under this subtitle.

17 (a) (1) The Secretary may only designate an area as an enterprise zone if the
 18 area:

19 (i) in a priority funding area or in a qualified opportunity zone
 20 under § 1400Z–1 of the Internal Revenue Code in Allegany County, Garrett County,
 21 Somerset County, or Wicomico County or meets an exception under Title 5, Subtitle 7B of
 22 the State Finance and Procurement Article; and

23 (ii) satisfies at least one of the requirements specified in paragraph
 24 (2) of this subsection.

17 (2) (i) “Business entity” means:

18 1. a person conducting or operating a trade or business; or

19 2. an organization that is exempt from taxation under §
 20 501(c)(3) or (4) of the Internal Revenue Code.

21 (ii) “Business entity” does not include a person owning, operating,
 22 developing, constructing, or rehabilitating property intended for use primarily as single or
 23 multifamily residential property located within the enterprise zone.

24 (3) “Economically disadvantaged individual” means an individual who is
 25 certified by provisions that the Maryland Department of Labor adopts as an individual who,
 26 before becoming employed by a business entity in an enterprise zone:

27 (i) was both unemployed for at least 30 consecutive days and
 28 qualified to participate in training activities for the economically disadvantaged under the
 29 federal Workforce Innovation and Opportunity Act or its successor; or

30 (ii) in the absence of an applicable federal act, met the criteria for an
 31 economically disadvantaged individual that the Secretary of Labor sets.

1 (4) (i) “Enterprise zone” has the meaning stated in § 5–701 of the
2 Economic Development Article.

3 (ii) “Enterprise zone” includes a Regional Institution Strategic
4 Enterprise zone established under Title 5, Subtitle 14 of the Economic Development Article.

5 (5) “Focus area” has the meaning stated in § 5–701 of the Economic
6 Development Article.
