A BILL ENTITLED

1 AN ACT concerning

2 **Professional Standards and Teacher Education Board – Composition –**
3 **Alteration**

4 FOR the purpose of altering the composition of the Professional Standards and Teacher
5 Education Board by adding a member of the Maryland Association of Nonpublic
6 Special Education Facilities; and generally relating to the Professional Standards
7 and Teacher Education Board.

8 BY repealing and reenacting, with amendments,
9 Article – Education
10 Section 6–703
11 Annotated Code of Maryland
12 (2018 Replacement Volume and 2021 Supplement)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Education**

16 6–703.

17 (a) (1) The Board consists of **[25] THE FOLLOWING** members[.

18 (2) Of the 25 Board members]:

19 (i) **[8 shall be] EIGHT** public school classroom teachers, as follows:

20 1. **[6 shall be] SIX** chosen from a list of nominees provided by
21 the statewide teachers' organization representing a majority of teachers in the State for
22 collective bargaining purposes; and

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 2. [2 shall be] **TWO** chosen from a list of nominees provided
2 by a statewide teachers’ organization representing teachers in at least one jurisdiction
3 within the State for collective bargaining purposes other than the majority organization
4 provided for in item 1 of this subparagraph;

5 (ii) [1 shall be a] **ONE** certified nonpublic school classroom teacher,
6 chosen from a list of nominees provided by the Association of Independent Schools;

7 (iii) [6 shall be] **SIX** teacher education faculty members from colleges
8 of the State, chosen from a list of nominees provided by:

- 9 1. The Maryland Association of Teacher Educators; and
- 10 2. The Maryland Association of Colleges of Teacher
11 Education;

12 (iv) [4 shall be] **FOUR** administrative or supervisory staff members
13 of public schools, as follows:

- 14 1. [2 shall be] **TWO** chosen from a list of nominees provided
15 by the Public School Superintendents’ Association of Maryland;
- 16 2. [1 shall be] **ONE** chosen from a list of nominees provided
17 by the Maryland Association of Secondary Principals; and
- 18 3. [1 shall be] **ONE** chosen from a list of nominees provided
19 by the Maryland Association of Elementary School Administrators;

20 (v) [2 shall be] **ONE** administrative or supervisory staff of the
21 approved nonpublic schools of the State, chosen from a list of nominees provided by the
22 Association of Independent Schools;

23 (vi) [1 shall be a] **ONE** member of a local board of education, chosen
24 from a list of nominees provided by the Maryland Association of Boards of Education;

25 **(VII) ONE MEMBER OF THE MARYLAND ASSOCIATION OF**
26 **NONPUBLIC SPECIAL EDUCATION FACILITIES, CHOSEN FROM A LIST OF NOMINEES**
27 **PROVIDED BY THE MARYLAND ASSOCIATION OF NONPUBLIC SPECIAL EDUCATION**
28 **FACILITIES;**

29 [(vii)] **(VIII) [2 shall be] TWO** representatives of the general public, as
30 follows:

- 31 1. [1 shall be] **ONE** chosen from a list of nominees provided
32 by the Speaker of the House of Delegates of Maryland; and

1 2. [1 shall be] **ONE** chosen from a list of nominees provided
2 by the President of the Senate of Maryland; and

3 [(viii)] **(IX)** [1 shall be] the State Superintendent or a designee of the
4 State Superintendent.

5 [(3)] **(2)** The Board shall include all the members of the Professional
6 Standards and Teacher Education Advisory Board serving on July 1, 1991.

7 (b) (1) The Governor, with the advice and consent of the Senate of Maryland,
8 shall appoint the members of the Board described in subsection [(a)(2)(i)] **(A)(1)(I)** through
9 [(vii)] **(VIII)** of this section.

10 (2) In making the appointments required under this subsection, the
11 Governor shall ensure that the Board is representative of:

12 (i) The geographic regions of the State; and

13 (ii) Minority populations of the State as defined in § 9–301 of the
14 State Government Article.

15 (c) (1) The term of an appointed member is 3 years.

16 (2) The terms of the appointed members are staggered as required by the
17 terms provided for members of the Board on October 1, 1991.

18 (3) At the end of a term, a member continues to serve until a successor is
19 appointed.

20 (4) A member who is appointed after a term has begun serves only for the
21 remainder of the term and until a successor is appointed and qualifies.

22 (d) The Governor may remove a member for incompetence or misconduct.

23 (e) From among its members, the Board annually shall elect a chairman.

24 (f) A majority of the members of the Board then serving on the Board is a quorum.

25 (g) The staff for the Board shall be provided by the State Board.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
27 1, 2022.
