## Real Property - Residential Leases - Rent Increase Restrictions

- FOR the purpose of prohibiting a landlord from increasing rent on a certain restricted rental unit by more than a certain percentage each year, subject to certain exceptions; providing additional restrictions on rent increases during and following a state of emergency; providing that rent restrictions for restricted rental units do not apply once rent is at least a certain amount each month; and generally relating to rent restrictions for residential leases.

- 6 (II) A GROUP OF TENANTS, SUBTENANTS, LESSEES, OR
- 7 SUBLESSEES OF A RESTRICTED RENTAL UNIT; OR
- 8 (III) ANOTHER INDIVIDUAL ENTITLED TO THE USE OR
- 9 OCCUPANCY OF THE RESTRICTED RENTAL UNIT.
- 10 (B) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, A LANDLORD MAY
- 11 NOT INCREASE RENT ON A RESTRICTED RENTAL UNIT BY MORE THAN 2% EACH
- 12 **YEAR.**
- 13 (C) IF THE LEASE FOR A RESTRICTED RENTAL UNIT IS FOR A TERM OF 1
- 14 MONTH AND RENEWED ON A MONTHLY BASIS BY THE TENANT, THE LANDLORD MAY
- 15 NOT INCREASE RENT ON THE RESTRICTED RENTAL UNIT BY MORE THAN 1% EVERY
- 16 **6 MONTHS.**
- 17 (D) IF THE RENT FOR A RESTRICTED RENTAL UNIT UNDER SUBSECTION (B)
- 18 OR (C) OF THIS SECTION IS BELOW FAIR MARKET RENT, THE LANDLORD MAY
- 19 INCREASE RENT TO REACH FAIR MARKET RENT BY AN ADDITIONAL:
- 20 (1) 4% IN THE FIRST YEAR THE RENT IS INCREASED UNDER THIS
- 21 SUBSECTION; AND
- 22 (2) 1% IN ANY SUBSEQUENT YEAR THE RENT IS INCREASED UNDER
- 23 THIS SUBSECTION.
- 24 (E) (1) DURING A STATE OF EMERGENCY AND FOR A 12-MONTH PERIOD
- 25 AFTER THE END OF THE STATE OF EMERGENCY, A LANDLORD MAY NOT INCREASE
- 26 **RENT**:
- 27 (I) BY MORE THAN 1% EACH YEAR FOR A RESTRICTED RENTAL
- 28 UNIT DESCRIBED IN SUBSECTION (B) OF THIS SECTION; OR
- 29 (II) By more than 0.5% every 6 months for a restricted
- 30 RENTAL UNIT DESCRIBED IN SUBSECTION (C) OF THIS SECTION.

- 1 (2) IF THE RENT FOR A RESTRICTED RENTAL UNIT UNDER SUBSECTIONS (B) AND (C) OF THIS SECTION IS BELOW FAIR MARKET RENT, THE LANDLORD MAY NOT INCREASE RENT TO REACH FAIR MARKET VALUE AND MAY ONLY INCREASE RENT IN ACCORDANCE WITH PARAGRAPH (1) OF THIS SUBSECTION.
- 5 (F) THE RESTRICTIONS ON RENT INCREASES IN THIS SECTION DO NOT 6 APPLY AFTER THE RENT OF A RESTRICTED RENTAL UNIT REACHES AT LEAST \$2,250 7 EACH MONTH.
- 8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 9 October 1, 2022.
