4 FOR the purpose of authorizing the Department of Natural Resources to allow a person ~~in~~
5 ~~Caroline County and Queen Anne's County to hunt any game bird or game mammal~~
6 ~~on a Sunday during the open season for that game bird or game mammal to hunt~~
7 *during a certain time period on certain Sundays of the game bird and game mammal*
8 *seasons in Caroline County, Dorchester County, and Queen Anne's County;* and
9 generally relating to Sunday hunting in Caroline County, Dorchester County, and
10 Queen Anne's County.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Natural Resources

(a) (1) (I) The Department may allow a person to hunt on each Sunday of the game bird and game mammal seasons in:

5. 6. SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, QUEEN ANNE'S COUNTY, FROM 30 MINUTES BEFORE SUNRISE UNTIL 10:30 A.M.;

(II) THE TIME RESTRICTIONS UNDER SUBPARAGRAPH (I) 2 AND 5 6 OF THIS PARAGRAPH DO NOT APPLY:

1. ON EACH SUNDAY DURING THE DEER FIREARMS SEASON;

1 **2. ON THE LAST THREE SUNDAYS IN OCTOBER AND THE**
 2 **FIRST TWO SUNDAYS IN NOVEMBER DURING THE DEER BOW HUNTING SEASON; AND**

3 **3. ON EACH SUNDAY OF THE SPRING TURKEY HUNTING**
 4 **SEASON.**

5 **(III) THE TIME RESTRICTIONS UNDER SUBPARAGRAPH (I)4 OF**
 6 **THIS PARAGRAPH DO NOT APPLY:**

7 **1. ON EACH SUNDAY OF THE DEER HUNTING SEASONS**
 8 **FROM THE FIRST SUNDAY IN OCTOBER THROUGH THE SECOND SUNDAY IN**
 9 **JANUARY, INCLUSIVE; AND**

10 **2. ON EACH SUNDAY OF THE SPRING TURKEY HUNTING**
 11 **SEASON.**

12 (2) The Department may allow a person to hunt deer on each Sunday of the
 13 deer hunting seasons from the first Sunday in October through the second Sunday in
 14 January, inclusive, in:

15 (i) Carroll County; **AND**

16 ~~(ii) Dorchester County; and~~

17 ~~(iii)~~ **(II)** Frederick County.

18 (3) (i) Subject to subparagraph (ii) of this paragraph, the Department
 19 may allow a person to hunt deer on each Sunday of the deer hunting seasons from 30
 20 minutes before sunrise until 10:30 a.m. in:

21 1. Kent County; and

22 2. Montgomery County.

23 (ii) The time restrictions under this paragraph do not apply:

24 1. To a participant in a junior deer hunt authorized under
 25 this subtitle;

26 2. On one Sunday designated by the Department during the
 27 deer firearms season;

28 3. In Kent County, on each Sunday during the deer bow
 29 hunting season and the deer muzzle loader season; and

- 3 6.] Somerset County;
- 4 [7.] ~~6.~~ 5. Talbot County;

7 (ii) The first Sunday in November in Anne Arundel County.

8 (6) The Department may allow a person to hunt turkey on each Sunday of
 9 the spring turkey hunting season in:

- 10 (i) Calvert County;
- 11 (ii) ~~Caroline County;~~
- 12 ~~(iii)~~ Carroll County;
- 13 ~~(iv)~~ (III) Charles County; AND
- 14 ~~(v)~~ (IV) ~~Dorchester County; and~~
- 15 ~~(vi)~~ (V) (IV) Kent County.

16 (7) Notwithstanding any other provision of this subtitle, the Department
 17 may allow a person with a deer management permit to shoot deer on any Sunday
 18 throughout the year in accordance with the terms of the permit.

19 (8) The Department may allow a person using a State certified raptor to
 20 hunt game birds or mammals on each Sunday during the open season for the game birds
 21 or mammals.

22 (9) The Department may allow an unarmed person participating in an
 23 organized fox chase to chase foxes on Sunday.

24 (10) The Department may allow a person shooting pen-reared game birds
 25 or tower-released flighted mallard ducks to hunt on Sunday at a regulated shooting ground
 26 in accordance with § 10-906 of this title.

1 (11) The Department may allow a person who is 16 years old or younger to
2 hunt on Sunday if participating in a junior hunt established by the Department in
3 accordance with this subtitle.

4 (12) Except as provided in paragraphs (8) through (10) of this subsection and
5 subject to paragraph (7) of this subsection, a person may not hunt on Sunday in:

6 (i) Baltimore City;

7 (ii) Baltimore County;

8 (iii) Howard County; or

9 (iv) Prince George's County.

10 (13) A person may not hunt migratory game birds on Sunday.

11 (14) A person may not hunt on public land within the State park system on
12 Sunday.

13 (15) The Department may not allow a person to hunt on public land
14 designated for hunting by the Department on Sunday except in:

15 (i) Allegany County;

16 (ii) Cecil County;

17 (iii) Garrett County;

18 (iv) St. Mary's County;

19 (v) Washington County;

20 (vi) Dorchester County, for turkey during the spring turkey hunting
21 season; and

22 (vii) Frederick County, for deer from the first Sunday in October
23 through the second Sunday in January of the following year, inclusive.

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
25 1, 2022.
