SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
That the Laws of Maryland read as follows:

**Article – Human Services**

7–111.

(a) (1) There is a State Coordinator for Autism Strategy in the Governor’s  
Office of Community Initiatives.

~~(2) WITH THE ADVICE AND CONSENT OF THE SENATE, THE~~ **THE**  
**GOVERNOR SHALL APPOINT THE STATE COORDINATOR FOR AUTISM STRATEGY.**

(e) (1) For fiscal year 2023 and each fiscal year thereafter, the Governor shall include in the annual budget bill an appropriation to fund the position of State Coordinator for Autism Strategy and the Advisory Stakeholder Group on Autism–Related Needs.

**(2) FOR FISCAL YEAR 2024 AND EACH FISCAL YEAR THEREAFTER, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION IN AN AMOUNT SUFFICIENT TO FUND ONE SUPPORT STAFF POSITION FOR THE STATE COORDINATOR FOR AUTISM STRATEGY.**

(a) There is an Advisory Stakeholder Group on Autism–Related Needs.

(b) The Advisory Stakeholder Group on Autism–Related Needs consists of the following members:

**(1) ONE MEMBER OF THE SENATE OF MARYLAND, APPOINTED BY THE PRESIDENT OF THE SENATE;**

**(2) TWO MEMBERS OF THE HOUSE OF DELEGATES, APPOINTED BY THE SPEAKER OF THE HOUSE;**

**[(1)] (3) the State Superintendent of Schools, or the State Superintendent’s designee;**

- 1            [(2)] (4)        the Secretary of Disabilities, or the Secretary’s designee;
- 2            [(3)] (5)        the Secretary of Human Services, or the Secretary’s designee;
- 3            [(4)] (6)        the Secretary of Health, or the Secretary’s designee;
- 4            [(5)] (7)        the State Coordinator for Autism Strategy;
- 5            [(6)] (8)        one representative of the Maryland Speech–Language–Hearing
- 6 Association;
- 7            [(7)] (9)        one representative of the Maryland Developmental Disabilities

- 9            [(8)] (10)       one representative of the Maryland Occupational Therapy
- 10 Association;
- 11           [(9)] (11)       one representative of The ARC Maryland;
- 12           [(10)] (12)      one representative of Pathfinders for Autism;
- 13           [(11)] (13)      one representative of Itineris; ~~and~~
- 14           [(12)] (14)      the following members, appointed by the Governor:
  - 15                    (i)     a school psychologist;
  - 16                    (ii)    a physical therapist;
  - 17                    (iii)   a pediatrician;
  - 18                    (iv)    two parents of children with autism;
  - 19                    (v)     two self–advocates with autism;
  - 20                    (vi)    one representative of public universities in the State;
  - 21                    (vii)   one representative of local public school systems in the State;
  - 22                    (viii) one representative from the business community; and

 25 autism–related needs as considered necessary, APPOINTED BY THE STATE  
 26 COORDINATOR FOR AUTISM STRATEGY.

1           (c) The State Coordinator for Autism Strategy shall chair the Advisory  
2 Stakeholder Group on Autism–Related Needs.

3           (d) The [Department of Disabilities] **GOVERNOR’S OFFICE OF COMMUNITY**  
4 **INITIATIVES** shall provide staff for the Advisory Stakeholder Group on Autism–Related  
5 Needs.

6           (e) IN APPOINTING MEMBERS UNDER SUBSECTION (B) OF THIS SECTION,  
7 THE APPOINTING AUTHORITY SHALL CONSIDER THE GEOGRAPHICAL DIVERSITY OF  
8 THE STATE SO THAT THE COMPOSITION OF THE ADVISORY STAKEHOLDER GROUP  
9 ON AUTISM–RELATED NEEDS REFLECTS THE VARIOUS COMMUNITIES OF THE  
10 STATE.

11           **(F)** A member of the Advisory Stakeholder Group on Autism–Related Needs:

12                   (1) may not receive compensation as a member of the Advisory Stakeholder  
13 Group on Autism–Related Needs; but

14                   (2) is entitled to reimbursement for expenses under the Standard State  
15 Travel Regulations, as provided in the State budget.

16           **[(f)] (G)** The Advisory Stakeholder Group on Autism–Related Needs shall work  
17 with the State Coordinator for Autism Strategy to:

18                   (1) identify and evaluate existing services for individuals with autism and  
19 their families;

20                   (2) develop a strategic plan for addressing autism–related needs in the  
21 State;

22                   (3) promote, monitor, and evaluate implementation of the strategic plan;  
23 and

24                   (4) recommend and implement changes to the strategic plan.

25           **[(g)] (H)** (1) The Advisory Stakeholder Group on Autism–Related Needs shall  
26 hold its initial meeting on or before December 31, 2020.

27                   (2) Beginning in 2021, the Advisory Stakeholder Group on Autism–Related  
28 Needs shall meet quarterly each calendar year.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act ~~is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted~~ October 1, 2022.
