- 5 (C) "EFFECTIVE AIR RATE CHANGE" MEANS THE SUM OF THE OUTSIDE

- 9 2. The planned remediation measures that will
- 10 BE TAKEN IN THE CLASSROOM;
- 11 (II) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS
- 12 SUBSECTION, WITHIN 3 MONTHS OF THE DATE OF THE CARBON DIOXIDE
- 13 MONITORING THE SCHOOL SHALL IMPLEMENT TEMPORARY REMEDIATION
- 14 MEASURES, INCLUDING:
- 15 1. ADDING EXHAUST FANS OR ADDITIONAL AIR FILTERS
- 16 TO THE CLASSROOM; AND
- 2. Adjusting activity density in the classroom;
- 18 AND
- 19 (III) IN ACCORDANCE WITH THE POLICY AND IMPLEMENTATION
- 20 PLAN ESTABLISHED UNDER § 2–1605 OF THIS SUBTITLE:
- 21 1. INSPECT THE CLASSROOM; AND
- 22 WITHIN 1 YEAR FROM THE DATE OF THE CARBON
- 23 DIOXIDE MONITORING, PUT PERMANENT REMEDIATION MEASURES IN PLACE IN
- 24 CLASSROOMS WITH ELEVATED CARBON DIOXIDE READINGS, INCLUDING REPLACING
- 25 OR REPAIRING THE MECHANICAL VENTILATION SYSTEMS OR ADDING ADDITIONAL
- 26 MECHANICAL VENTILATION SYSTEMS TO THE CLASSROOM.
- 27 (2) IF THE DATE OF THE CARBON DIOXIDE READING IS DURING THE
- 28 LAST 3 MONTHS OF THE SCHOOL YEAR, THEN THE SCHOOL SHALL IMPLEMENT
- 29 TEMPORARY REMEDIATION MEASURES BY THE BEGINNING OF THE IMMEDIATELY
- 30 FOLLOWING SCHOOL YEAR.

- 1 (3) A CLASSROOM THAT HAS AN ELEVATED CARBON DIOXIDE 2 READING SHALL:
- 3 (I) BE RETESTED EVERY 4 MONTHS UNTIL THE CLASSROOM
- 4 RECEIVES A CARBON DIOXIDE READING BELOW 2,000 PARTS PER MILLION; AND
- 5 (II) CONTINUE WITH CARBON DIOXIDE MONITORING TWICE PER
- 6 YEAR AFTER THE CLASSROOM RECEIVES A CARBON DIOXIDE READING BELOW 2,000
- 7 PARTS PER MILLION.
- 8 (4) A PUBLIC SCHOOL SHALL REPEAT THE REQUIREMENTS OF THIS
- 9 SUBSECTION EACH TIME A CLASSROOM HAS AN ELEVATED CARBON DIOXIDE
- 10 **READING.**
- 11 **2–1605.**
- 12 (A) ON OR BEFORE JUNE 1, 2023, EACH COUNTY BOARD SHALL DEVELOP A
- 13 POLICY AND IMPLEMENTATION PLAN THAT DESCRIBES HOW INSPECTIONS AND
- 14 REMEDIATION OF CLASSROOMS THAT HAVE RECEIVED AN ELEVATED CARBON
- 15 DIOXIDE READING SHOULD OCCUR, INCLUDING WHO IS RESPONSIBLE FOR
- 16 SCHOOL-LEVEL HVAC SYSTEMS.
- 17 (B) EACH COUNTY BOARD SHALL SUBMIT A WRITTEN PLAN TO THE
- 18 DEPARTMENT WITHIN 1 YEAR OF THE ADOPTION OF THE POLICY AND

- 29 (3) THE MAXIMUM CARBON DIOXIDE CONCENTRATION READING OF
- 30 THE CLASSROOM:
 - (I) FROM THE CURRENT SCHOOL YEAR; AND

- 1 (II) FROM THE IMMEDIATELY PRECEDING SCHOOL YEAR TAKEN 2 BETWEEN DECEMBER 1 AND MARCH 30.
- 3 (B) ON OR BEFORE DECEMBER 15 EACH YEAR, EACH COUNTY BOARD 4 SHALL:
- 5 (1) COMPILE THE INFORMATION REPORTED UNDER SUBSECTION (A) 6 OF THIS SECTION;
- 7 (2) SEND THE INFORMATION TO THE DEPARTMENT AND THE STATE 8 DEPARTMENT OF EDUCATION;
- 9 (3) MAKE THE INFORMATION AVAILABLE ON THE COUNTY BOARD'S 10 WEBSITE; AND
- 11 (4) SEND NOTIFICATION TO THE SCHOOL COMMUNITY THAT 12 INCLUDES:
- 13 (I) BACKGROUND INFORMATION ON INDOOR AIR QUALITY;
- 14 (II) THE RESULTS OF ALL CARBON DIOXIDE MONITORING 15 CONDUCTED IN THE SCHOOL; AND
- 16 (III) IF APPLICABLE, ANY REQUIRED REMEDIATION MEASURES
 17 TAKEN AT THE SCHOOL RELATING TO INDOOR AIR QUALITY.
