1 AN ACT concerning

2 **Baltimore City – District Court – Jobs Court Pilot Program**

3 FOR the purpose of establishing the Jobs Court Pilot Program in the District Court sitting
4 in Baltimore City; requiring the Administrative Office of the Courts to take certain
5 actions including providing ~~a~~ certain ~~report~~ reports, in consultation with the
6 Baltimore Workforce Development Board, to the Governor and the General
7 Assembly on or before ~~a~~ certain ~~date~~ dates; and generally relating to the
8 establishment of the Jobs Court Pilot Program in Baltimore City.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

15 That the Laws of Maryland read as follows:

16 **Article – Criminal Procedure**

17 **6–236.**

18 **(A) THERE IS A JOBS COURT PILOT PROGRAM IN THE DISTRICT COURT**
19 **SITTING IN BALTIMORE CITY.**

1 (B) THE PURPOSE OF THE PILOT PROGRAM IS TO REDUCE RECIDIVISM BY
2 OFFERING DEFENDANTS AN OPPORTUNITY TO PARTICIPATE IN FULL-TIME JOB
3 TRAINING AND JOB PLACEMENT PROGRAMS AS A CONDITION OF PROBATION, AN
4 ALTERNATIVE TO INCARCERATION, OR A CONDITION OF PRETRIAL RELEASE.

5 (C) TO ACCOMPLISH THE PURPOSE OF THE PILOT PROGRAM, THE
6 ADMINISTRATIVE OFFICE OF THE COURTS SHALL DEVELOP A PLAN TO IMPLEMENT
7 AND MONITOR THE PILOT PROGRAM.

8 (D) (1) ON OR BEFORE JUNE 30, 2025, THE ADMINISTRATIVE OFFICE OF
9 THE COURTS, IN CONSULTATION WITH THE BALTIMORE WORKFORCE
10 DEVELOPMENT BOARD, SHALL SUBMIT AN INTERIM REPORT TO THE GOVERNOR
11 AND, IN ACCORDANCE WITH § 2-1257 OF THE STATE GOVERNMENT ARTICLE, THE
12 GENERAL ASSEMBLY ON THE OPERATION AND RESULTS OF THE PILOT PROGRAM.

13 (2) ON OR BEFORE JUNE 30, 2027, THE ADMINISTRATIVE OFFICE OF
14 THE COURTS, IN CONSULTATION WITH THE BALTIMORE WORKFORCE
15 DEVELOPMENT BOARD, SHALL SUBMIT A FINAL REPORT TO THE GOVERNOR AND,
16 IN ACCORDANCE WITH § 2-1257 OF THE STATE GOVERNMENT ARTICLE, THE
17 GENERAL ASSEMBLY ON THE OPERATION AND RESULTS OF THE PILOT PROGRAM.

18 SECTION 2. AND BE IT FURTHER ENACTED, That ~~for~~ in each of fiscal year years
19 2024, 2025, 2026, 2027, and 2028, the Governor shall include in the annual State budget
20 an appropriation of at least \$500,000 to the Baltimore Workforce Development Board, to
21 be distributed to local workforce investment boards or other nonprofit entities that
22 participate in the pilot program by identifying employers and training programs.

23 SECTION 3. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall take
24 effect July 1, 2023.

25 SECTION ~~3~~ 4. AND BE IT FURTHER ENACTED, That, except as provided in
26 Section 3 of this Act, this Act shall take effect July 1, 2022. It shall remain effective for a
27 period of ~~5~~ 6 years and, at the end of June 30, ~~2027~~ 2028, this Act, with no further action
28 required by the General Assembly, shall be abrogated and of no further force and effect.
