BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 2 (a) In this section, "compulsory process" includes a subpoena, summons, warrant, 3 or court order that appears on its face to have been issued on lawful authority.
- 4 (b) A health care provider shall disclose a medical record without the 5 authorization of a person in interest:
 - (7) Subject to the additional limitations for a medical record developed primarily in connection with the provision of mental health services in § 4–307 of this subtitle, AND THE LIMITATIONS ON PATIENT OVERDOSE INFORMATION UNDER § 13–3602(E) OF THIS ARTICLE, to grand juries, prosecution agencies, law enforcement agencies or their agents or employees to further an investigation or prosecution, pursuant to a subpoena, warrant, or court order for the sole purposes of investigating and prosecuting criminal activity, provided that the prosecution agencies and law enforcement agencies have written procedures to protect the confidentiality of the records;

- 15 (a) An emergency medical services provider or a law enforcement officer who 16 treats and releases or transports to a medical facility an individual experiencing a 17 suspected or an actual overdose may report the incident using an appropriate information 18 technology platform with secure access, including the Washington/Baltimore High 19 Intensity Drug Trafficking Area overdose detection mapping application program, or any 20 other program operated by the federal government or a unit of State or local government.
- 21 (b) A report of an overdose made under this section shall include:
- 22 (1) The date and time of the overdose;
- 23 (2) The approximate address where the overdose victim was initially 24 encountered or where the overdose occurred;
 - (3) Whether an opioid overdose reversal drug was administered; and
- 26 (4) Whether the overdose was fatal or nonfatal.
- 27 (c) If an emergency medical services provider or a law enforcement officer reports 28 an overdose under this section, the emergency medical services provider or law enforcement 29 officer making the report shall make best efforts to make the report within 24 hours after 30 responding to the incident.
 - (d) On receipt of a patient care report that indicates an overdose, the Maryland Institute for Emergency Medical Services Systems shall report the information listed under subsection (b) of this section to an appropriate information technology platform with secure access, including the Washington/Baltimore High Intensity Drug Trafficking Area overdose

3 4 5	(e) Overdose information reported by an emergency medical services provider under subsection (a) of this section or by the Maryland Institute for Emergency Medical Services Systems under subsection (d) of this section may not be [used]:

7 8	(2) OBTAINED BY A LAW ENFORCEMENT OFFICER AS PART OF A CRIMINAL INVESTIGATION OR PROSECUTION.
9 10 11	(f) An emergency medical services provider or a law enforcement officer who in good faith makes a report under this section shall be immune from criminal liability for making the report.
