State and Local Parks – Child Safe Zone Program – Establishment (Equitable Access to Safe Parks Act)

FOR the purpose of establishing the Child Safe Zone Program in the Department of Natural Resources; establishing the Child Safe Zone Fund as a special, nonlapsing fund, to provide funding for capital and operating expenses associated with enhancing public safety in State and local parks; and generally relating to public safety at State and local parks.

16 WHEREAS, Enhancing access to public parks improves the physical and mental 17 health of children and families; and

18 WHEREAS, Children who witness violence are more likely to suffer adverse health19 and social impacts; and

WHEREAS, Children and families are entitled to an expectation of safety in public spaces such as parks; and

WHEREAS, It is in the interest of children, their families, and all Marylanders for the State to encourage the safe and healthy utilization of parks on a regular basis; and

1 WHEREAS, The designation of State and local parks as Child Safe Zones will 2 communicate to the public that parks are intended to serve as safe community gathering 3 spaces and thereby provide safe havens for children; now, therefore,

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 5 That the Laws of Maryland read as follows:

9 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS 10 INDICATED.

11 **(B) "CHILD SAFE ZONE" MEANS A DESIGNATION THAT COMMUNICATES THE** 12 **EXPECTATION THAT AN AREA IS SAFE FOR CHILDREN AND THEIR FAMILIES.**

13 (C) "FUND" MEANS THE CHILD SAFE ZONE FUND ESTABLISHED UNDER § 14 5–2003 OF THIS SUBTITLE.

15 (D) "PROGRAM" MEANS THE CHILD SAFE ZONE PROGRAM ESTABLISHED 16 UNDER § 5–2002 OF THIS SUBTITLE.

17 **5–2002.**

18 (A) THERE IS A CHILD SAFE ZONE PROGRAM IN THE DEPARTMENT.

19 (B) THE PURPOSE OF THE PROGRAM IS TO:

20 (1) IMPROVE AND ENHANCE PUBLIC SAFETY AT STATE AND LOCAL 21 PARKS THROUGH MEASURES FUNDED UNDER § 5–2003 OF THIS SUBTITLE;

22 (2) INSTALL SIGNAGE IN PROMINENT AREAS OF EACH STATE PARK 23 IDENTIFYING THE PARKS AS CHILD SAFE ZONES; AND

24 (3) FACILITATE COLLABORATION WITH LOCAL JURISDICTIONS TO 25 DESIGNATE LOCAL PARKS AS CHILD SAFE ZONES.

26 (C) A CHILD SAFE ZONE DESIGNATED UNDER THIS SECTION SHALL 27 INCLUDE THE AREA SURROUNDING THE PARK, WITHIN 50 FEET OF THE PARK'S 28 BOUNDARIES.

1 (D) THE DEPARTMENT SHALL COMMUNICATE THE IDENTIFICATION OF 2 STATE PARKS AS CHILD SAFE ZONES TO THE PUBLIC IN ITS MARKETING 3 MATERIALS.

4 **5–2003.**

5 (A) THERE IS A CHILD SAFE ZONE FUND.

6 (B) THE PURPOSE OF THE FUND IS TO PROVIDE FUNDING FOR CAPITAL AND 7 OPERATING EXPENSES ASSOCIATED WITH ENHANCING PUBLIC SAFETY IN STATE 8 AND LOCAL PARKS.

9 (C) THE DEPARTMENT SHALL ADMINISTER THE FUND.

10 (D) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT 11 SUBJECT TO § 7–302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

12 (2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY, 13 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.

14 (E) THE FUND CONSISTS OF:

15(1) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND;16AND

17 (2) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR 18 THE BENEFIT OF THE FUND.

19 (F) (1) THE FUND MAY BE USED ONLY FOR:

20(I)CAPITAL AND OPERATING EXPENSES OF THE DEPARTMENT21ASSOCIATED WITH ENHANCING PUBLIC SAFETY IN STATE PARKS; AND

(II) GRANTS TO LOCAL GOVERNMENTS FOR CAPITAL AND
 OPERATING EXPENSES ASSOCIATED WITH ENHANCING PUBLIC SAFETY IN LOCAL
 PARKS.

25 (2) PUBLIC SAFETY MEASURES ELIGIBLE FOR FUNDING UNDER THIS 26 SECTION INCLUDE:

27 (I) INFRASTRUCTURE IMPROVEMENTS THAT ENHANCE PUBLIC 28 SAFETY, SUCH AS ENHANCED LIGHTING, SECURITY AND SURVEILLANCE CAMERAS, 29 LANDSCAPING, IMPROVED ACCESS, TRASH RECEPTACLES, AND OTHER IMPROVEMENTS IDENTIFIED BY THE DEPARTMENT BASED ON NATIONAL INDUSTRY
 BEST PRACTICES; AND

3 (II) INCREASED STAFFING FOR GENERAL OPERATIONS, 4 INCLUDING APPROPRIATE SECURITY AND LAW ENFORCEMENT PERSONNEL.

5 (G) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND 6 IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.

7 (2) ANY INTEREST EARNINGS OF THE FUND SHALL BE CREDITED TO 8 THE GENERAL FUND OF THE STATE.

9 (H) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE 10 WITH THE STATE BUDGET.

11 (I) MONEY EXPENDED FROM THE FUND IS SUPPLEMENTAL TO AND IS NOT 12 INTENDED TO TAKE THE PLACE OF FUNDING THAT OTHERWISE WOULD BE 13 APPROPRIATED FOR PUBLIC SAFETY MEASURES IN STATE AND LOCAL PARKS.

14 SECTION 2. AND BE IT FURTHER ENACTED, That for fiscal year 2024, the 15 Governor shall include in the annual budget bill an appropriation of at least \$1,000,000 to 16 the Child Safe Zone Fund.

17 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 18 October 1, 2022.
