14 15	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

18 19 20 21	(a) A person [who fails] MAY NOT FAIL to comply with the relief granted in an interim protective order under $\S 4-504.1(c)(1)$ , (2), (3), (4)(i), (7), or (8) of this subtitle, a temporary protective order under $\S 4-505(a)(2)(i)$ , (ii), (iii), (iv), (v), or (viii) of this subtitle, or a final protective order under $\S 4-506(d)(1)$ , (2), (3), (4), or (5), or (f) of this subtitle.
22	(B) A PERSON WHO VIOLATES SUBSECTION (A) OF THIS SECTION is guilty of

a misdemeanor and on conviction is subject, for each offense, to:

- 1 (1) for a first offense, a fine not exceeding \$1,000 or imprisonment not exceeding 90 days or both; and
- 3 (2) for a second or subsequent offense, a fine not exceeding \$2,500 or 4 imprisonment not exceeding 1 year or both.
- 5 (C) NOTWITHSTANDING ANY OTHER LAW, A CONVICTION UNDER THIS 6 SECTION MAY NOT MERGE WITH A CONVICTION FOR ANY OTHER CRIME BASED ON 7 THE ACT ESTABLISHING THE VIOLATION OF THIS SECTION.
- 8 **(D)** A SENTENCE IMPOSED UNDER THIS SECTION MAY BE IMPOSED 9 SEPARATE FROM AND CONSECUTIVE TO OR CONCURRENT WITH A SENTENCE FOR 10 ANY CRIME BASED ON THE ACT ESTABLISHING THE VIOLATION OF THIS SECTION.
- [(b)] **(E)** For the purpose of second or subsequent offender penalties provided under subsection [(a)(2)] **(B)(2)** of this section, a prior conviction under § 3–1508 of the Courts Article shall be considered a conviction under this section.
- [(c)] **(F)** An officer shall arrest with or without a warrant and take into custody a person who the officer has probable cause to believe is in violation of an interim, temporary, or final protective order in effect at the time of the violation.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2022.
