1 AN ACT concerning

2 **Career Pathways for Health Care Workers Program**

3 FOR the purpose of establishing the Career Pathways for Health Care Workers Program
4 in the Maryland Department of Labor for the purpose of providing matching grants
5 to eligible employers for training programs attended by health care workers; and
6 generally relating to the Career Pathways for Health Care Workers Program.

7 BY adding to

8 Article – Labor and Employment

9 Section 11–1501 through 11–1507 to be under the new subtitle “Subtitle 15. Career
10 Pathways for Health Care Workers Program”

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Labor and Employment**

16 **SUBTITLE 15. CAREER PATHWAYS FOR HEALTH CARE WORKERS PROGRAM.**

1 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS
2 INDICATED.

3 (B) "DIVISION" MEANS THE DIVISION OF WORKFORCE DEVELOPMENT AND
4 ADULT LEARNING.

5 (C) "ELIGIBLE EMPLOYER" MEANS A HOSPITAL OR RELATED INSTITUTION
6 AS THOSE TERMS ARE DEFINED IN § 19-301 OF THE HEALTH – GENERAL ARTICLE.

7 (D) "HEALTH CARE WORKER" MEANS:

8 (1) A WORKER LICENSED OR CERTIFIED UNDER TITLE 8 OF THE
9 HEALTH OCCUPATIONS ARTICLE; OR

10 (2) ANY OTHER INDIVIDUAL EMPLOYED BY AN ELIGIBLE EMPLOYER
11 WHO PROVIDES PERSONAL CARE, ASSISTANCE, OR TREATMENT SERVICES DIRECTLY
12 TO PATIENTS OR RESIDENTS IN THE COURSE OF THE WORKER'S REGULAR DUTIES.

13 (E) "HBCU" INCLUDES:

14 (1) BOWIE STATE UNIVERSITY;

15 (2) COPPIN STATE UNIVERSITY;

16 (3) MORGAN STATE UNIVERSITY; AND

17 (4) THE UNIVERSITY OF MARYLAND EASTERN SHORE.

18 (F) "PROGRAM" MEANS THE CAREER PATHWAYS FOR HEALTH CARE
19 WORKERS PROGRAM.

20 (G) "TRAINING PROGRAM" MEANS A TRAINING PROGRAM PROVIDED FOR
21 HEALTH CARE WORKERS BY AN HBCU OR A COMMUNITY COLLEGE.

23 (A) THERE IS A CAREER PATHWAYS FOR HEALTH CARE WORKERS
24 PROGRAM IN THE DEPARTMENT.

25 (B) THE DIVISION SHALL ADMINISTER THE PROGRAM.

26 (C) THE DIVISION MAY ADOPT REGULATIONS TO IMPLEMENT THE
27 PROGRAM.

2 (A) THE PURPOSE OF THE PROGRAM IS TO PROVIDE MATCHING GRANTS TO
3 ELIGIBLE EMPLOYERS THAT PAY FOR TRAINING PROGRAMS ATTENDED BY HEALTH
4 CARE WORKERS.

5 (B) THE GOAL OF THE PROGRAM IS TO PROVIDE INCREASED
6 OPPORTUNITIES FOR HEALTH CARE WORKERS TO RECEIVE TRAINING ACROSS THE
7 STATE.

8 11-1504.

9 (A) EACH YEAR, THE DIVISION SHALL ISSUE A REQUEST FOR APPLICATIONS
10 FROM ELIGIBLE EMPLOYERS FOR MATCHING GRANTS OFFERED UNDER THE
11 PROGRAM.

12 (B) TO RECEIVE A MATCHING GRANT UNDER THE PROGRAM, AN ELIGIBLE
13 EMPLOYER SHALL SUBMIT TO THE DIVISION AN APPLICATION WHICH SHALL
14 INCLUDE:

15 (1) A LIST OF TRAINING PROGRAMS THAT HEALTH CARE WORKERS
16 HAVE REQUESTED TO ATTEND DURING THE IMMEDIATELY FOLLOWING CALENDAR
17 YEAR;

18 (2) A LIST OF TRAINING PROGRAMS THAT A PARTICIPATING ELIGIBLE
19 EMPLOYER HAS IDENTIFIED BASED ON CURRENT LABOR MARKET NEEDS;

20 (3) THE COST OF ANY TRAINING PROGRAMS THAT HEALTH CARE
21 WORKERS HAVE ~~REQUESTED TO ATTEND~~ ATTENDED DURING THE IMMEDIATELY
22 ~~FOLLOWING~~ PRECEDING CALENDAR YEAR AND FOR WHICH ~~AN~~ THE ELIGIBLE
23 EMPLOYER ~~HAS~~ AGREED TO PAY;

24 ~~(3)~~ (4) SUFFICIENT DETAIL ABOUT A TRAINING PROGRAM TO
25 ALLOW THE DIVISION TO ENSURE THAT THE TRAINING PROGRAM MEETS THE
26 REQUIREMENTS OF THIS SUBTITLE; AND

27 ~~(4)~~ (5) AN ASSURANCE THAT THE TRAINING PROGRAM SHALL BE
28 PROVIDED AT NO COST TO A HEALTH CARE WORKER.

30 (A) IN EVALUATING THE APPLICATIONS SUBMITTED UNDER § 11-1504 OF
31 THIS SUBTITLE AND SELECTING ELIGIBLE EMPLOYERS TO RECEIVE A MATCHING
32 GRANT UNDER THE PROGRAM, THE DIVISION SHALL SECURE MATCHING CASH

1 CONTRIBUTIONS OR OTHER CONSIDERATION FOR TRAINING PROGRAMS DURING
2 THE IMMEDIATELY FOLLOWING CALENDAR YEAR IN AN AMOUNT AT LEAST EQUAL IN
3 VALUE TO THE AMOUNT REQUESTED FROM THE PROGRAM.

4 (B) (1) THE DIVISION MAY NOT AWARD A MATCHING GRANT THAT
5 EXCEEDS \$50,000 EACH YEAR TO AN ELIGIBLE EMPLOYER.

6 (2) IF THE DIVISION RECEIVED APPLICATIONS FOR MATCHING
7 GRANTS TOTALING MORE THAN THE AMOUNT OF FUNDS APPROPRIATED FOR THE
8 PROGRAM FOR A FISCAL YEAR, THE DIVISION SHALL AWARD THE GRANTS ON A PRO
9 RATA BASIS.

10 (C) A MATCHING GRANT AWARDED UNDER THE PROGRAM SHALL BE VALID
11 FOR 1 CALENDAR YEAR.

12 (D) AN ELIGIBLE EMPLOYER RECEIVING A MATCHING GRANT UNDER THE
13 PROGRAM SHALL USE THE GRANT TO SUPPLEMENT, AND NOT SUPPLANT, THE
14 AMOUNT OF FUNDS THAT, IN THE ABSENCE OF THE GRANT, WOULD BE AVAILABLE
15 TO PAY FOR THE TRAINING PROGRAMS TO BE ATTENDED BY HEALTH CARE WORKERS
16 DURING THE IMMEDIATELY FOLLOWING CALENDAR YEAR.

17 (E) AN ELIGIBLE EMPLOYER RECEIVING A GRANT UNDER THE PROGRAM
18 SHALL:

19 (1) PROVIDE TO EACH HEALTH CARE WORKER WHO IS CONSIDERING
20 ENROLLING IN A TRAINING PROGRAM INFORMATION RELATING TO THE WAGE
21 INCREASE REQUIRED TO BE PROVIDED UNDER ITEM (2) OF THIS SUBSECTION TO
22 HEALTH CARE WORKERS ON COMPLETION OF A TRAINING PROGRAM; AND

23 (2) PROVIDE A ~~10%~~ WAGE INCREASE THAT IS COMMENSURATE WITH
24 CURRENT LABOR MARKET TRENDS TO A HEALTH CARE WORKER WHO COMPLETES
25 AND RECEIVES A CERTIFICATION FOR A TRAINING PROGRAM FOR WHICH A GRANT
26 HAS BEEN AWARDED UNDER THE PROGRAM.

27 (F) (1) IF AN ELIGIBLE EMPLOYER AND AN EMPLOYEE ORGANIZATION OR
28 UNION BARGAIN COLLECTIVELY TO CREATE A TRAINING AND UPGRADING FUND
29 THAT PROVIDES EDUCATIONAL AND JOB TRAINING PROGRAMS AND BENEFITS
30 HEALTH CARE WORKERS, ANY GRANT MONEY FOR AN EMPLOYEE WHO IS A MEMBER
31 OF A BARGAINING UNIT AWARDED TO THE EMPLOYER UNDER THE PROGRAM SHALL
32 PASS THROUGH THE FUND.

33 (2) THE TRAINING AND UPGRADING FUND SHALL REPORT TO THE
34 DIVISION, IN THE MANNER SPECIFIED BY THE DIVISION, WHEN GRANT MONEY IS
35 EXPENDED BY THE TRAINING AND UPGRADING FUND.

2 (A) FOR EACH FISCAL YEAR, THE GOVERNOR SHALL INCLUDE IN THE
3 ANNUAL BUDGET BILL AN APPROPRIATION OF AT LEAST \$1,000,000 FOR THE
4 PROGRAM.

5 (B) APPROPRIATIONS AND EXPENDITURES MADE FOR THE PURPOSE OF
6 IMPLEMENTING THE PROGRAM, INCLUDING THE USE OF ANY FUNDS RECEIVED BY A
7 PERSON UNDER ANY COMPONENT OF THE PROGRAM, ARE SUBJECT TO AUDIT BY
8 THE OFFICE OF LEGISLATIVE AUDITS AS PROVIDED IN § 2-1220 OF THE STATE
9 GOVERNMENT ARTICLE.

11 (A) ON OR BEFORE DECEMBER 1 EACH YEAR, BEGINNING IN 2023, THE
12 DIVISION SHALL REPORT TO THE SENATE FINANCE COMMITTEE AND THE HOUSE
13 HEALTH AND GOVERNMENT OPERATIONS COMMITTEE, IN ACCORDANCE WITH §
14 2-1257 OF THE STATE GOVERNMENT ARTICLE, ON:

15 (1) THE AMOUNT OF GRANT FUNDS PROVIDED TO ELIGIBLE
16 EMPLOYERS FOR TRAINING PROGRAMS DURING THE REPORTING PERIOD;

17 (2) THE NUMBER OF HEALTH CARE WORKERS WHO ATTENDED
18 TRAINING PROGRAMS FOR WHICH GRANT FUNDS WERE USED DURING THE
19 REPORTING PERIOD; AND

20 (3) THE HBCUS OR COMMUNITY COLLEGES WHICH PROVIDED
21 TRAINING PROGRAMS TO HEALTH CARE WORKERS AND FOR WHICH GRANT FUNDS
22 WERE USED DURING THE REPORTING PERIOD.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 2022.
