1 (1) MEET AT LEAST FOUR TIMES EACH YEAR AT A TIME AND PLACE 2 DESIGNATED BY THE CHAIR;

3 (2) GATHER INFORMATION ON THE NEEDS OF HOMESCHOOL 4 PARENTS AND HOMESCHOOL UMBRELLA SCHOOLS IN THE STATE; AND

5 (3) ADVISE THE STATE SUPERINTENDENT, THE STATE BOARD, THE 6 GENERAL ASSEMBLY, AND THE GOVERNOR ON MATTERS RELATING TO 7 HOMESCHOOLING.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 9 1, 2022.
