FOR the purpose of requiring the Natalie M. LaPrade Medical Cannabis Commission, in consultation with certain stakeholders, to conduct a certain baseline study of cannabis use in the State; establishing the Cannabis Business Assistance Fund in the Department of Commerce as a special, nonlapsing fund to provide assistance to small, minority, and women-owned businesses entering the adult-use cannabis industry; altering certain provisions relating to penalties, charging procedures, expungement, shielding, and sentencing for certain offenses involving marijuana; legalizing the use and possession of a certain quantity of marijuana by a person who is at least a certain age; establishing the Cannabis Public Health Advisory Council; establishing the Cannabis Public Health Fund; establishing the Community <u>Reinvestment and Repair Fund</u>; adding the smoking of cannabis and hemp to certain provisions of law prohibiting smoking in certain indoor areas; allowing a subtraction modification under the Maryland income tax for certain expenses paid or incurred




