- 5 FOR the purpose of authorizing the Board of License Commissioners for Howard County to 6 issue a consumption only shopping mall plaza license and special event permit to the 7 owner of a commercial shopping mall if the mall meets certain criteria; authorizing 8 the license holder to allow the consumption of beer, wine, and liquor in a designated 9 outdoor area if the beer, wine, or liquor is purchased from certain restaurants; 10 establishing a shopping mall plaza special event permit; providing that the permit 11 authorizes certain restaurants to operate additional bars or service counters for the 12 sale and service of food and alcoholic beverages in a designated outdoor plaza during a special event; and generally relating to a consumption only shopping mall plaza 13 license and special event permit in Howard County. 14

(A) IN THIS SECTION, "SHOPPING MALL" MEANS A COMBINATION OF 5 6 COMMERCIAL, PROFESSIONAL, OR RETAIL ESTABLISHMENTS THAT: 7 **(1)** ARE OPEN TO THE GENERAL PUBLIC FOR BUSINESS PURPOSES; **(2)** 8 ARE UNDER COMMON OWNERSHIP OR CONTROL; 9 **(3)** SHARE COMMON PARKING FACILITIES; AND 10 **(4)** ENCOMPASS AT LEAST 60 ACRES. - 1 (E) AS PART OF THE LICENSE APPLICATION, AN OWNER OF A SHOPPING 2 MALL SHALL INCLUDE:
- 3 **(1)** A DESCRIPTION OF THE DESIGNATED OUTDOOR PLAZA AND A LIST 4 OF THE CONTIGUOUS LICENSE HOLDERS WHOSE BEER, WINE, AND LIQUOR MAY BE
- 5 CONSUMED IN THE DESIGNATED OUTDOOR PLAZA; AND
- 6 **(2)** A SECURITY PLAN THAT HAS BEEN APPROVED BY THE HOWARD 7 COUNTY POLICE DEPARTMENT.
- 8 THE LICENSE HOLDER MAY ALLOW THE CONSUMPTION OF BEER, WINE, 9 AND LIQUOR IN THE DESIGNATED OUTDOOR PLAZA ON MONDAY THROUGH SUNDAY, FROM 11 A.M. TO 11 P.M. 10
- 11 (G) THE ANNUAL LICENSE FEE IS \$4,000.
- IN THIS SUBSECTION, "PARTICIPATING RESTAURANT" MEANS A 12 **(1)** RESTAURANT DESCRIBED UNDER SUBSECTION (D) OF THIS SECTION THAT 13
- PARTICIPATES IN A COORDINATED PROMOTION OF A SPECIAL EVENT WITH THE 14
- OWNER OF A SHOPPING MALL IN WHICH THE RESTAURANT IS LOCATED. 15
- **(2)** 16 **(I)** THERE IS A SHOPPING MALL PLAZA SPECIAL EVENT 17 PERMIT.
- THE BOARD MAY ISSUE THE PERMIT ONLY TO THE HOLDER 18 (II)OF A CONSUMPTION ONLY SHOPPING MALL PLAZA LICENSE. 19
- 20 THE HOLDER OF A CONSUMPTION ONLY SHOPPING MALL PLAZA LICENSE SHALL APPLY TO THE BOARD FOR THE PERMIT BEFORE THE HOLDER OR A 2122PARTICIPATING RESTAURANT MAY PUBLICIZE, SELL TICKETS FOR, ORGANIZE, 23OPERATE, PRODUCE, OR STAGE THE SPECIAL EVENT.
- 24**(4)** THE PERMIT AUTHORIZES PARTICIPATING RESTAURANTS TO 25 OPERATE ADDITIONAL BARS OR SERVICE COUNTERS FOR THE SALE AND SERVICE OF 26 FOOD AND ALCOHOLIC BEVERAGES IN THE DESIGNATED OUTDOOR PLAZA 27 DESCRIBED UNDER THE CONSUMPTION ONLY SHOPPING MALL PLAZA LICENSE 28 **DURING A SPECIAL EVENT.**
- 29 **(5)** THE PERMIT FEE IS \$500.
- 30 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 31 1, 2022.
