1 AN ACT concerning

2 **Child Care Capital Support Revolving Loan Fund – Established**

3 FOR the purpose of establishing the Child Care Capital Support Revolving Loan Fund as
4 a special, nonlapsing fund; requiring interest earnings of the Fund to be credited to
5 the Fund; requiring the ~~State Department of Education~~ Department of Commerce to
6 administer the Fund with support from the State Department of Education;
7 requiring the Department of Commerce to publicize the availability of loans from the
8 Fund; and generally relating to the Child Care Capital Support Revolving Loan
9 Fund.

5 (A) (1) IN THIS SECTION, THE FOLLOWING WORDS HAVE THE MEANINGS
6 INDICATED.

7 (2) "FUND" MEANS THE CHILD CARE CAPITAL SUPPORT REVOLVING
8 LOAN FUND.

9 (3) "RURAL COMMUNITY" HAS THE MEANING STATED IN § 2-207 OF
10 THE STATE FINANCE AND PROCUREMENT ARTICLE.

11 (B) THERE IS A CHILD CARE CAPITAL SUPPORT REVOLVING LOAN FUND.

12 (C) THE PURPOSE OF THE FUND IS TO PROVIDE NO-INTEREST LOANS FOR
13 CAPITAL EXPENSES TO CHILD CARE PROVIDERS WHO PARTICIPATE IN THE CHILD
14 CARE SCHOLARSHIP PROGRAM UNDER § 9.5-113 OF THIS ~~TITLE~~ SUBTITLE.

15 (D) THE DEPARTMENT OF COMMERCE SHALL ADMINISTER THE FUND WITH
16 SUPPORT FROM THE DEPARTMENT.

17 (E) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT
18 SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE THAT
19 SHALL BE AVAILABLE IN PERPETUITY FOR THE PURPOSE OF PROVIDING LOANS IN
20 ACCORDANCE WITH THE PROVISIONS OF THIS SECTION.

21 (2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY,
22 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.

23 (F) THE FUND CONSISTS OF:

24 (1) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND;

25 (2) ANY INTEREST EARNINGS OF THE FUND;

26 (3) REPAYMENTS OF PRINCIPAL AND INTEREST FROM LOANS MADE
27 FROM THE FUND; AND

28 (4) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR
29 THE BENEFIT OF THE FUND.

1 (G) (1) THE FUND MAY BE USED ONLY TO PROVIDE NO-INTEREST LOANS
 2 TO CHILD CARE PROVIDERS FOR CAPITAL EXPENSES RELATED TO A CHILD CARE
 3 FACILITY, INCLUDING:

4 (I) ACQUISITION;

5 (II) EXPANSION;

6 (III) RENOVATIONS; AND

7 (IV) NEW CONSTRUCTION.

8 (2) (I) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS
 9 PARAGRAPH, CHILD CARE PROVIDERS SHALL REPAY LOANS FROM THE FUND NOT
 10 LATER THAN 5 YEARS AFTER RECEIVING A LOAN FROM THE FUND.

11 (II) THE DEPARTMENT OF COMMERCE MAY ESTABLISH A
 12 FINANCIAL HARDSHIP EXEMPTION TO ALLOW A CHILD CARE PROVIDER ADDITIONAL
 13 TIME TO REPAY A LOAN FROM THE FUND.

14 (III) IF A HARDSHIP EXEMPTION IS NOT GRANTED, THE
 15 DEPARTMENT OF COMMERCE SHALL APPLY ITS NORMAL POLICY REGARDING
 16 ASSISTING CHILD CARE PROVIDERS WITH PAST DUE LOAN PAYMENTS.

17 (H) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND
 18 IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.

19 (2) ANY INTEREST EARNINGS OF THE FUND SHALL BE CREDITED TO
 20 THE FUND.

21 (I) (1) THE DEPARTMENT OF COMMERCE, IN CONSULTATION WITH THE
 22 DEPARTMENT, SHALL ESTABLISH APPLICATION PROCEDURES AND ELIGIBILITY
 23 CRITERIA FOR LOANS FROM THE FUND, INCLUDING:

24 ~~(1) REQUIRING~~ IN ADDITION TO THE REQUIREMENT THAT A CHILD
 25 CARE PROVIDER TO BE A PARTICIPANT IN THE CHILD CARE SCHOLARSHIP
 26 PROGRAM UNDER § 9.5-113 OF THIS TITLE; AND SUBTITLE.

 28 DEPARTMENT SHALL PRIORITIZE APPLICANT CRITERIA IN THE FOLLOWING ORDER

(II) CHILD CARE PROVIDERS THAT ARE LOCATED IN RURAL COMMUNITIES;

(III) ~~SERVE~~ CHILD CARE PROVIDERS THAT SERVE PRIMARILY LOW-INCOME POPULATIONS IN AREAS OF HIGH POVERTY;

~~(IV)~~ (IV) ~~SERVE~~ CHILD CARE PROVIDERS THAT SERVE CHILDREN WITH SPECIAL NEEDS; ~~OR~~ AND

~~(V)~~ (V) ~~SERVE~~ CHILD CARE PROVIDERS THAT SERVE CHILDREN AGES 2 AND YOUNGER.

(J) THE DEPARTMENT OF COMMERCE SHALL WORK WITH THE DEPARTMENT TO PUBLICIZE THE AVAILABILITY OF LOANS FROM THE FUND AND PROVIDE SUPPORT TO CHILD CARE PROVIDERS IN APPLYING FOR LOANS FROM THE FUND.

(K) (1) FOR FISCAL YEAR 2023, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION TO THE FUND OF \$15,000,000.

(2) FOR FISCAL YEAR 2024, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION TO THE FUND OF \$10,000,000.

~~(3) FOR FISCAL YEAR 2025, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION TO THE FUND OF \$5,000,000.~~

6–226.

(a) (2) (i) Notwithstanding any other provision of law, and unless inconsistent with a federal law, grant agreement, or other federal requirement or with the terms of a gift or settlement agreement, net interest on all State money allocated by the State Treasurer under this section to special funds or accounts, and otherwise entitled to receive interest earnings, as accounted for by the Comptroller, shall accrue to the General Fund of the State.

1 (ii) The provisions of subparagraph (i) of this paragraph do not apply
2 to the following funds:
