A BILL ENTITLED

1 AN ACT concerning

2 **Human Services – Two Generation Family Economic Security**
3 **Commission – Membership and Compensation**

4 FOR the purpose of increasing the membership of the Two Generation Family Economic
5 Security Commission; requiring that a certain member of the Commission receive
6 certain compensation; and generally relating to the Two Generation Family
7 Economic Security Commission.

8 BY repealing and reenacting, with amendments,

11 Annotated Code of Maryland

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Human Services**

16 2–503.

17 (a) The Commission consists of the following members:

18 (1) the Secretary, who shall serve as the ex officio chair of the Commission;

19 (2) two members of the Senate, appointed as follows:

20 (i) one member of the Senate Budget and Taxation Committee,
21 appointed by the President of the Senate; and

22 (ii) one member appointed by the Minority Leader of the Senate;

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 (3) two members of the House of Delegates, appointed as follows:

2 (i) one member of the House Appropriations Committee, appointed
3 by the Speaker of the House; and

4 (ii) one member appointed by the Minority Leader of the House of
5 Delegates;

6 (4) the Secretary of Housing and Community Development, or the
7 Secretary's designee;

8 (5) the Secretary of Disabilities, or the Secretary's designee;

9 (6) the Secretary of Health, or the Secretary's designee;

10 (7) the Secretary of Labor, or the Secretary's designee;

11 (8) the Secretary of Juvenile Services, or the Secretary's designee;

12 (9) the Superintendent of the Maryland State Department of Education, or
13 the Superintendent's designee;

14 (10) one director of a local department of social services, appointed by the
15 Secretary of Human Services in consultation with the Maryland Association of Social
16 Services Directors;

17 (11) one county health officer, appointed by the Secretary of Health in
18 consultation with the Maryland Association of County Health Officers;

19 (12) one member appointed by the Maryland Association of Community
20 Colleges; [and]

21 (13) two public members appointed by the Governor, including at least one
22 parent with experience in child welfare advocacy or community action partnerships; AND

23 **(14) ONE MEMBER APPOINTED BY THE SECRETARY OF HUMAN**
24 **SERVICES WHO LIVED IN AND EXPERIENCED POVERTY IN MARYLAND AND WHO WAS,**
25 **WITHIN THE PAST 3 YEARS BEFORE APPOINTMENT TO THE COMMISSION, A**
26 **RECIPIENT OF PUBLIC ASSISTANCE BASED ON THE INDIVIDUAL'S POVERTY.**

27 (b) To the extent practicable, appointments under this section shall ensure
28 geographic diversity among the membership of the Commission.

29 (c) (1) This subsection applies to commissioners appointed under subsection
30 (a)(10) through (13) of this section.

1 (2) The term of a commissioner is 4 years.

2 (3) The terms of the members are staggered as required by the terms
3 provided for members of the Commission on October 1, 2020.

4 (4) At the end of a term, a commissioner continues to serve until a successor
5 is appointed.

6 (5) A commissioner who is appointed after a term has begun serves only for
7 the rest of the term and until a successor is appointed.

8 (d) The Department shall provide staff for the Commission.

9 (e) **(1)** A member of the Commission:

10 **[(1)] (I) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
11 **SUBSECTION, may not receive compensation as a member of the Commission; but**

12 **[(2)] (II)** is entitled to reimbursement for expenses under the Standard
13 State Travel Regulations, as provided in the State budget.

14 **(2) (I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE**
15 **MEMBER OF THE COMMISSION APPOINTED UNDER SUBSECTION (A)(14) OF THIS**
16 **SECTION SHALL BE ENTITLED TO A STIPEND AS PROVIDED IN THE STATE BUDGET.**

17 **(II) THE AMOUNT OF THE STIPEND SHALL BE RECOMMENDED**
18 **BY THE SECRETARY AND APPROVED BY THE COMMISSION.**

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
20 1, 2022.
