2 **Prince George's County – Alcoholic Beverages Licenses – Limits**

3 **PG 305–22**

4 FOR the purpose of increasing the maximum number of Class B beer, wine, and liquor  
5 licenses that the Board of License Commissioners for Prince George's County may  
6 issue; and generally relating to alcoholic beverages licenses in Prince George's  
7 County.
