BY repealing and reenacting, without amendments, Article – State Finance and Procurement Section 5A–330(a) and (b) Annotated Code of Maryland (2021 Replacement Volume) BY repealing and reenacting, with amendments, Article – State Finance and Procurement Section 5A–330(c), (e), and (f)(2) Annotated Code of Maryland (2021 Replacement Volume)
