2 **Primary and Secondary Education – Virtual Education – Requirements**

3 FOR the purpose of requiring the Professional Standards and Teacher Education Board to
4 design a certain course of training in the pedagogy of virtual education; requiring
5 the State Department of Education to provide local school systems with guidance
6 related to the periodic professional development and support for teachers to achieve
7 virtual education best practice principles; ~~establishing the Flip the Classroom Pilot~~
8 ~~Program~~; requiring the Department, on or before a certain date, to establish a
9 statewide universal learning management system for public schools and hire a
10 dedicated employee to implement and manage the system; requiring a county board
11 of education to adopt the universal learning management system under certain
12 circumstances; requiring the Department, beginning in a certain school year, to
13 make certain curriculum standards available through the universal management
14 learning system; repealing certain provisions of law related to online courses and
15 services; authorizing a county board to request the Department's development or
16 approval of a new virtual education course; repealing certain provisions of law
17 regarding the establishment of virtual schools; requiring the Department to develop
18 guidelines for the appropriate development, review, and assessment of digital
19 services; prohibiting the approval of a virtual school in the State on or before a
20 certain date; requiring the Department to develop criteria for the establishment of
21 virtual schools on or before a certain date; providing for the administration and
22 operation of temporary virtual schools under certain circumstances; requiring a
23 county board to establish learning centers under certain circumstances; requiring
24 the Department to administer grants to provide virtual education high school
25 courses; requiring the Governor to appropriate certain funds for certain virtual

(a) The Department shall, in consultation with experienced and highly effective teachers, including teachers on the career ladder under Title 6, Subtitle 10 of this article, develop curriculum standards and curriculum resources for each subject at each grade level, that build on one another in logical sequence, in core subjects that may be used by local school systems and public school teachers.

(b) (1) The purpose of the curriculum standards and curriculum resources developed under this section is to provide county boards with technical assistance to inform high-quality instruction that will ultimately result in students meeting the college and career readiness standards in the manner described under § 7-205.1 of this subtitle.

(2) The curriculum resources developed under this section shall include, for each core subject at each grade level:

(i) Course syllabi;

(ii) Sample lessons for teachers to use as models;

(iii) Examples of student work that meet standards for proficiency;

(iv) Explanations of why student work examples meet proficiency standards so that teachers know what student knowledge is required; and

(v) Curriculum units aligned with the course syllabi.

(3) In developing the curriculum resources under this subsection, the Department:

1 (i) May use as a model a course or unit developed by a teacher in or
2 out of the State; but

3 (ii) Shall review each model course and unit for quality, using
4 accepted benchmarks such as approval by EdReports or Tier 1 and Tier 2 evidence-based
5 standards established by the federal Every Student Succeeds Act.

6 (4) The Department shall compile curriculum units in such a manner that:

7 (i) Complete courses are formed; and

8 (ii) When taken by a student in sequence, the student can achieve
9 the college and career readiness standard adopted under § 7–205.1 of this subtitle by the
10 end of grade 10.

11 (c) The Department shall submit curriculum resources and curriculum standards
12 developed under this section to the State Board for adoption.

13 (d) **(1) (I) ON OR BEFORE SEPTEMBER 1, 2022, THE DEPARTMENT**
14 **SHALL:**

15 **1. ESTABLISH A STATEWIDE UNIVERSAL LEARNING**
16 **MANAGEMENT SYSTEM FOR EVENTUAL USE IN ALL PUBLIC SCHOOLS IN THE STATE;**

12 (3) If the Department, based on a recommendation of an Expert Review
13 Team, determines that a school’s low performance on assessments is, largely, due to
14 curricular problems, the school shall adopt the curriculum resources developed under this
15 section.

16 (4) Except as provided in paragraph (3) of this subsection, this section does
17 not require a public school or county board to adopt the Department’s curriculum standards
18 and curriculum resources and may not be construed to restrict a county board’s authority
19 to adopt curricula under § 4–111 of this article.

22 include:

23 (1) Offering a distance-learning program to provide Maryland public
24 school students with equal opportunities to develop a strong academic foundation;

27 (3) Expanding the professional development opportunities available to
28 educational staff in Maryland public schools through **[online] VIRTUAL EDUCATION**

24 **[(2)] (3)** (i) [Subject to subparagraph (ii) of this paragraph, the
 25 Department shall:

26 1. A. Develop online courses and services; or

27 B. Review and approve online courses and services;

28 2. Develop standards for teachers and other school system
 29 employees for the offering of courses or services on the Internet or through other developing
 30 technologies; and

31 3. Review courses and courseware to assure quality and
 32 alignment with the Maryland content standards and other appropriate standards.

1 (ii) Subject to subparagraph (v) of this paragraph, the Department
2 may delegate the authority to develop or review and approve online courses and services to
3 a county board.

4 (iii) If the Department delegates the authority to develop or review
5 and approve online courses and services to a county board, the county board may impose
6 reasonable fees to be paid by the vendor to cover the cost of reviewing and approving online
7 courses and services.

8 (iv) A county board shall remit 15% of the fees collected under
9 subparagraph (iii) of this paragraph to the Department.

10 (v) 1. **A] AFTER A county board HAS FINISHED DEVELOPING**
11 **A NEW VIRTUAL EDUCATION COURSE, THE COUNTY BOARD** shall [request approval of
12 the online course from] **SUBMIT THE PROPOSED NEW COURSE TO** the Department [when
13 the county board has completed the development or] **FOR** review and approval [of online
14 courses and services].

15 **[2.] (II)** Within 45 days after [a request] **RECEIVING A**

30 of the course and provide feedback to the [course provider] **COUNTY BOARD**.

31 **(5) THE DEPARTMENT SHALL DEVELOP GUIDELINES FOR THE**
32 **APPROPRIATE DEVELOPMENT, REVIEW, AND ASSESSMENT OF DIGITAL SERVICES.**

33 (c) **[(1)** There is a Maryland Virtual Learning Opportunities Fund.

34 (2) The State Board may set reasonable fees for:

- 1 (i) Developing or reviewing online courses and services;
- 2 (ii) Processing approvals for online courses and services;
- 3 (iii) Developing an assessment regarding the accessibility of an
4 online course or service to individuals with disabilities, including the blind; and
- 5 (iv) Assessing an online course for its accessibility to individuals with
6 disabilities, including the blind.

7 (3) The fees charged shall be set so as to produce funds to support
8 maintenance of Maryland virtual learning opportunities.

9 (4) The State Board shall pay all funds collected under this subtitle to the
10 Comptroller of the State.

11 (5) The Comptroller shall distribute the fees to the Maryland Virtual
12 Learning Opportunities Fund.

13 (6) The Fund is a continuing, nonlapsing fund not subject to § 7–302 of the
14 State Finance and Procurement Article.

15 (7) Any unspent portions of the Fund may not be transferred or revert to
16 the General Fund of the State, but shall remain in the Fund to be used for the purposes
17 specified in this subtitle.

18 (8) The Legislative Auditor shall audit the accounts and transactions of the
19 Fund as provided in § 2–1220 of the State Government Article.]

20 **(1) (I) ANY VIRTUAL EDUCATION COURSES OFFERED BY A COUNTY**
21 **BOARD SHALL BE OFFERED THROUGH SYNCHRONOUS LEARNING.**

22 **(II) A COUNTY BOARD MAY NOT ENROLL MORE STUDENTS IN A**
23 **VIRTUAL EDUCATION COURSE THAN A TEACHER MAY REASONABLY BE EXPECTED TO**
24 **MEANINGFULLY ENGAGE WITH DURING VIRTUAL EDUCATION.**

25 **(2) A TEACHER OF A VIRTUAL EDUCATION COURSE:**

26 **(I) MAY NOT BE REQUIRED TO SIMULTANEOUSLY INSTRUCT**
27 **STUDENTS ATTENDING THE TEACHER’S CLASSROOM IN PERSON; AND**

28 **(II) SHALL HAVE OTHER DUTIES, INCLUDING TEACHING,**
29 **MENTORING, AND LEADING DUTIES REQUIRED UNDER TITLE 6, SUBTITLE 10 OF**
30 **THIS ARTICLE, REDUCED BY A REASONABLE AMOUNT TO COMPENSATE FOR THE**
31 **TIME SPENT TEACHING THE VIRTUAL EDUCATION COURSE.**

14 **CERTIFICATION OF INCOME ELIGIBILITY UNDER ANY OF THE FOLLOWING:**

15 (1) **SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM;**

16 (2) **TEMPORARY ASSISTANCE FOR NEEDY FAMILIES;**

17 (3) **FOSTER CARE;**

18 (4) **HEAD START;**

19 (5) **EVEN START;**
