## A BILL ENTITLED

FOR the purpose of altering certain commissions that certain licensed agents receive from certain lottery ticket sales and that certain veterans organizations receive from sales of tickets from certain instant ticket lottery machines; requiring the Governor, in certain fiscal years, to include in the annual State budget an appropriation of at least a certain amount to the Maryland Veterans Trust Fund; and generally relating to commissions for sales of lottery tickets and tickets from instant ticket lottery machines.
