## A BILL ENTITLED

## 1 AN ACT concerning

## Natural Resources - Oysters - Spat, Shells, and Substrate

3 FOR the purpose of establishing various programs, goals, research requirements, planning 4 requirements, and funding requirements related to oyster spat, oyster shells, and 5 oyster substrate; requiring the Maryland Agricultural and Resource-Based Industry 6 Development Corporation to provide loans and grants up to a certain amount to 7 finance the eligible costs of certain eligible seafood processing projects; replacing the 8 oyster shell recycling tax credit with an annual grant program administered by the 9 Department of Natural Resources; requiring the Maryland Geological Survey, in conjunction with certain other entities, to conduct certain bottom surveys; requiring 10 11 the University of Maryland Center for Environmental Science to conduct research 12 related to substrate in collaboration with certain entities; requiring the Department 13 to develop a certain substrate plan; providing for the construction and expansion of certain oyster hatcheries; and generally relating to oysters. 14

- 1 (a) The Department may resurvey any submerged area of the State to determine 2 the position and extent of any natural oyster bar.
- 3 (b) If, after conducting a survey in accordance with subsection (a) of this section, 4 the Department finds that any natural oyster bar is located incorrectly on existing charts 5 or that the existing charts do not reflect the actual condition of submerged lands, the 6 Department shall amend the existing charts or coordinates by regulation.

- 8 (3) alternative substrates used for oyster restoration or repletion in other 9 regions, including the success of efforts to use alternative substrates; and
- 10 (4) the potential for retrofitting existing structures, such as riprap 11 revetments, that are unrelated to oyster restoration but that use materials similar to 12 artificial reefs, to include oyster plantings.
- 13 (b) On or before December 1, 2025, the University of Maryland Center for Environmental Science shall report to the Secretary of Natural Resources and, in accordance with § 2–1257 of the State Government Article, the General Assembly on its research findings under this section.
- 17 (c) For fiscal years 2024 and 2025, the Governor shall include in the annual budget bill an appropriation of \$250,000 for the University of Maryland Center for Environmental Science to carry out the research required under this section.

## 20 SECTION 4. AND BE IT FURTHER ENACTED, That:

- 21 (a) On or before December 1, 2023, the Department of Natural Resources shall submit a plan to the Governor and, in accordance with § 2–1257 of the State Government Article, the General Assembly describing the substrate needs for oyster restoration and repletion activities in the State over the next 10 years.
- 25 (b) The plan shall include:
- 26 (1) an estimate of the quantity of the substrate materials that will be 27 needed and the purposes for which the substrate materials will be used;
- 28 (2) an overview of the full spectrum of substrate materials available;
- 29 (3) an analysis of the availability, sourcing, and relative cost of each 30 substrate material;
- 31 (4) an estimate of the total and annual costs of implementing the plan; and
- 32 (5) opportunities for improving the cost-effectiveness of substrate 33 acquisition and use, including opportunities for increasing coordination with the

- 1 Commonwealth of Virginia, undertaking larger—scale projects to take advantage of economies of scale, and reducing mobilization and demobilization costs.
- 3 SECTION 5. AND BE IT FURTHER ENACTED, That:
- 4 (a) It is the intent of the General Assembly that by 2025, oyster hatcheries in the 5 State shall be capable of producing 5 billion spat—on—shell per year.
- 6 (b) To reach the goal established under subsection (a) of this section, for fiscal year 2024, the Governor shall include in the annual operating or capital budget:
- 8 (1) an appropriation of \$20,000,000 for the University of Maryland Center 9 for Environmental Science to build a second oyster hatchery, to be named after Michael E.
- 10 Busch, former Speaker of the House of Delegates; and
- 11 (2) an appropriation of \$2,500,000 for the Patuxent Environmental and 12 Aquatic Research Laboratory, Morgan State University, to be used for infrastructure
- 13 upgrades to support increased oyster production for research and restoration.
- SECTION 6. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall be applicable to all taxable years beginning after December 31, 2021.
- SECTION 7. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2022.
