

- 25 (b) Except as provided in subsection (d) of this section, in accordance with the regulations of the Agency and this subtitle, the Director shall issue licenses to the persons and governmental units that will best serve the public convenience and promote the sale of State lottery tickets or shares.
- $29\,$ (c) Before issuing a license to an applicant, the Director shall consider such $30\,$ factors as:



- 1 REMIT THE RECEIPTS FROM THE SALE OF TICKETS FROM INSTANT TICKET LOTTERY

- 25 (IV) IT IS THE INTENT OF THE GENERAL ASSEMBLY THAT, WHEN
- 26 THE AGENCY SOLICITS PROPOSALS FOR THE PURCHASE OR LEASE OF INSTANT
- 27 TICKET LOTTERY MACHINES UNDER SUBPARAGRAPH (III)2B OF THIS PARAGRAPH,

- 3 (5) The Director may adopt regulations to implement the provisions of this subsection that include restricting the location of instant ticket lottery machines in areas of a veterans' organization's **OR FRATERNAL ORGANIZATION'S** public meeting hall that is accessible to the public.
- The Agency shall ensure that the element of chance in the conduct of the gaming through the instant ticket lottery machines established under this subsection is consistent with the holding in the case of Chesapeake Amusements Inc. v. Riddle, 363 Md. 16 (2001), in that the element of chance must be wholly within the pre-printed instant lottery ticket, and that player enhancements in an instant ticket lottery machine may not affect the element of chance being wholly within the pre-printed instant lottery ticket.
- 13 (e) The Director may not issue a license to:
- 14 (1) a person or governmental unit to engage in business primarily as a 15 licensed agent; or
- 16 (2) an individual who is under the age of 21 years.
- 17 (f) The Commission may hear and decide an appeal of a denial of a license.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2022.
